## Grounds for the International Tort Claim and Arrest Warrant of all bonds

The grounds for this international complaint include but are not limited to the violation of the intangible property right to honest services of which, if any Articles within the Universal Declaration of Human Rights (UDHR)<sup>1</sup> are violated, dishonest services are revealed to the International Community through those violations, to wit;

## Profiled as Sovereign Citizen by offices that do not lawfully exist

Any attempt to profile a documented American National as a "Sovereign Citizen"<sup>2</sup>, or arrest, detain, or isolate a documented American National from their Government, or any attempt to intimidate, threaten or perpetrate any other arbitrary action including but not limited to passive-aggressive and gang stalking against Derek William Davidson or any documented American National, for whatever reason, is an offense against the UDHR and the Convention on the Rights of the Child (CRC).<sup>3</sup>

Further offenses include but not limited to attempted murder by classification of a private record of a domestic terrorist spread all over the country at large thereby continually threatening the profiled on a daily basis with loss of life and limb.

Further, any attempt of retaliation by claiming terrorism against Derek William Davidson or any American National or the Government of The United States of America by any American Bar Association (ABA) member or any of its agencies will result in an immediate attempted murder charge against said perpetrators.

Any non-recognition of the American National status is a contract violation and falls under the slavery clause of the UDHR and the International Covenant on Civil and Political Rights (CCPR)<sup>4</sup>. If Derek William Davidson or any documented American National is not recognized as having the right to contract, then the ABA and its members are claiming that the documented American National is a slave to the ABA. This claim is a violation and subjects the ABA trustee to immediate arrest for slavery and attempted murder.

## Trafficking

Derek William Davidson is a documented American National and therefore, a non-citizen, non-resident alien to the United States of America and does business under the Articles of Confederation of 1781 brought forward and amended August 5<sup>th</sup>, 2015.

Derek William Davidson and all American Nationals have no affiliations nor memberships within the AMERICAN BAR ASSOCIATION (ABA), nor any of its State Bar association subsidiaries.

Further, the American Bar Association and its subsidiaries do not exist in any State Constitution nor in any charter within the United States and are therefore unrecognized within the United States as having any authority to issue any obligation or bond that would hold the people under a financial obligation.

Any action taken by any private membership association against the Public is arbitrary and nefarious thereby subjecting the private company that operates under the aforesaid association to international crimes under the UDHR, the CRC and the CCPR.

Further, the vicar general of each created jurisdiction is liable for international war crimes against the people committed by His Excellency's private government, Head Quartered at the White House in the city of Washington D.C., a city-state that operates as a private company, and

Despite these facts — established as part of the International Record — members of the ABA and its subsidiaries continue to pursue various forms of prosecution against Derek William Davidson and American Nationals. This is a violation of Article 3, 6, 7, 8, 15, 17 and 20 (2) of the UDHR and Article 7 (1) of the CRC.

The failure of each BAR entity to adhere to their proper jurisdiction, that of regulating only the conduct of their members, reveals the violation of the intangible property rights to honest services.

Any attempt to grant DEREK WILLIAM DAVIDSON, PMA or DEREK WILLIAM DAVIDSON membership into any Bar Association— such act being committed on July 12, 2016 by Jackie Lacey — is felony conversion of a private record and constitutes a nefarious act by a private association and its trustee and the company that operates under its authority registered in the State of Delaware and the U.S. Department of Defense.

These acts also reveal violations of the American Declaration of the Rights and Duties of Man<sup>5</sup>, implemented under The Bar Treaty of 1947, to which, all members of the ABA and its subsidiaries are subject. The Bar Treaty of 1947 cannot hold the people liable to it as the Bar has never lawfully existed within the United States nor is it recognized by the constitution of the United States or the present day Articles of Confederation.

These acts are also a violation of Executive Order #13107, "The Implementation of Human Rights Treaties", signed December 10, 1998 by U.S. President William Jefferson Clinton<sup>6</sup>, on behalf of His Excellency's private government.

We also include this text from the U.S. Department of Defense, Combating Trafficking in Persons website, "On December 16, 2002, the President (George Bush, Jr.) signed National Security Presidential Directive 22 declaring the United States' zero tolerance policy for trafficking in persons (TIP)" <sup>7</sup>, declared by His Excellency's private government.

## **Denial of Nationality / Forced Contract**

The Federal Reserve Note (FRN) is a private religious script and is unrecognized by the Constitution of the United States. As an unrecognized private religious script that has been allowed to circulate across the continent, the FRN has transformed the American society into a Black Market, perhaps the largest in recorded history. This reduces anyone that uses the unrecognized FRN to criminal black market participants and renders all transactions using FRNs illegal.

The Government of The United States of America has introduced a National currency, the Continental Dollar, in various denominations. This National currency has been denied access to the international financial system because of these black market activities within international financial systems. This is a denial of a Nationality and a violation of Article 15 of the UDHR.

Further, Derek William Davidson (and all American Nationals) is repeatedly denied the right to use the Continental Dollar for goods and services and is instead forced to use this private religious script. This is a forced contract as well as a violation of religious freedom guaranteed by the UDHR and enforceable under customary international law.

## **Fraud upon the Court if it lawfully existed – Bringing False Claims**

As previously noted, Derek William Davidson, and all American Nationals, are non-citizen, non-resident aliens to the United States of America and have no affiliations nor memberships with the ABA nor any of its State subsidiaries. The continued persecution of Derek William Davidson and American Nationals represents false claims brought by members of these private associations, and reveals systemic violations of the intangible property right to honest services as the ABA continually exercises an attachment doctrine thereby attaching John Doe and Jane Doe cases to existing cases never revealing to the Public at Large this conversion of the record. The conversion of the record causes a legal trap wherein the defendant unknowingly never defends against the international accusation thereby being convicted of crimes that were never on the domestic record. This condition creates the illusion of a voluntary act on the part of the defendant to be found guilty of international crimes without ever knowing the charge(s) existed.

## **Violation of Due Process**

It is self-evident that a “biased” or “tainted” court, or a court that is party to conspiracy or a court that does not lawfully exist, fails any reasonable standards of due process and honest services tendered to anyone who is trafficked to the private courts. Therefore, the General Post Master Council retains full jurisdiction over documented American Nationals by voluntary contract on the part of the documented American National under full disclosure.

## **Human Rights Violations and Intangible Property**

As previously noted, Executive Order #13107, "The Implementation of Human Rights Treaties", makes the United States a party to the Universal Declaration of Human Rights through His Excellency's private government.





It is evident to this Government that the ABA and its State Bar subsidiaries consistently fail to acknowledge international law and habitually violate terms of agreements to which they are a party. As private membership associations, the ABA and its State Bar subsidiaries cannot compel membership from American Nationals nor the Public at Large. To do so is a violation of Article 20(2) of the UDHR and the American Declaration of the Rights and Duties of Man, implemented under The Bar Treaty of 1947.

It is also evident to this Government, that the ABA and its State Bar subsidiaries understand they are private membership associations and understand the strict limits of their authority to within the association as well as holding authority within any private companies that are created by that association.

Therefore, this conduct (trafficking in persons and property, violations of due process, bringing of false claims, etc.) cannot be accidental and must be considered systemic and nefarious --- a conspiracy designed to agitate, intimidate, harm or destroy the lives of American Nationals and the Public at Large. These nefarious acts have led to indefinable anguish and pain suffered by the persecuted. Inexplicably, this conduct is allowed to continue as the ABA and its States Bar subsidiaries plunder countless estates, reduce millions to homelessness and incarcerate individuals that are not members of their associations.

Further, a **mercenary** is a person who takes part in an armed conflict who is not a national or a party to the conflict and is "motivated to take part in the hostilities by the desire for private gain.

Since the ABA is not recognized by the constitution of the United States, it is not a national or a party to any conflict within the United States. Then we can conclude that an ABA member would fall under the mercenary category internationally and any police officer that takes orders from an ABA member would also qualify for the mercenary category internationally. This condition does enlighten those that pay attention as to why a correct oath or affirmation is the difference between the category of mercenary or the category of National. We can also conclude that the ABA and its State subsidiaries is foreign to the United States and The United States of America and therefore would be required to register under the Foreign Agents Registration Act that the ABA wrote and published.

## **AFFIDAVIT OF FACT**

Comes now, Derek William Davidson-Trustee, who brings this claim on behalf of DEREK WILLIAM DAVIDSON, PMA, hereinafter "Affiant" against THE CITY OF GLENDORA, Glendora Police Department. Being competent to testify, after first being duly sworn according to law to tell the truth to the facts related herein, Affiant has firsthand knowledge of the facts stated herein and believes these facts to be true to the best of Affiant's knowledge and belief.

### **Statement of Fact**

1. On Sunday, April 17, 2016, Affiant attended a small get together at 721 South Pasadena Avenue, Glendora, California. On or about 2:00 a.m. Pacific Time, Affiant exited the location in the company of Jessica M. Garcia. Affiant and Jessica M. Garcia began to proceed northbound, on foot, to access Jessica M. Garcia's vehicle which was located on Route 66, in Glendora, California. A Glendora Police Department vehicle was traveling northbound on South Pasadena Avenue, observed Affiant and Jessica M. Garcia and turned on East Colorado. Jessica M. Garcia returned to the South Pasadena Avenue location because Jessica M. Garcia had forgotten an item. Affiant crossed South Pasadena Avenue. The Glendora Police Department vehicle returned and proceeded to park on the east side of South Pasadena Avenue, facing south.
2. Glendora Police Department Corporal Tim Crawford, Patrol Division, hereinafter "Respondent #1", exited the vehicle, with his hand on his gun. Respondent #1 stated "Good evening, how are you doing"? Affiant responded "Fine, how are you"? Respondent #1 stated "Why don't you have a seat on this curb right here for me"? Affiant responded "Sure, no problem". Affiant proceeded to then sit on the curb where designated. (Note: Respondent #1 was the only police presence on-site at this time).
3. Respondent #1 proceeded to make small talk, inclusive of asking Affiant what Affiant was up to tonight and where Affiant was coming from. Affiant responded that Affiant had had a couple of drinks with Affiant's girlfriend at Affiant's friend's house down the street. Respondent #1 asked "That wouldn't by chance be the house with the for sale sign"? Affiant responded "Yea, why"? Respondent #1 asked if Affiant's girlfriend would still possibly be at the house. Affiant responded that Affiant couldn't say. Respondent #1 asked Affiant for girlfriend's name. Affiant responded "Julia Garcia". Respondent #1 asked for Affiant's identification. Affiant gave Respondent #1, INTERNATIONAL DRIVER LICENSE, ID: 233657404 and THE UNITED STATES OF AMERICA, International Motor Traffic, International Translation of Driving Permit, No 233657404. Affiant stated that Affiant was a non-U.S. citizen and a non-resident alien. Respondent #1 stated "Oh, you are one of those sovereigns". Affiant responded "No sir, I am not a sovereign, but my country is sovereign". Respondent #1 stated "No, you're a sovereign". Affiant responded, "No sir, I am not a sovereign, my country is sovereign". Respondent #1 stated that Respondent #1 has been trained extensively in the behavior of sovereign citizens and how to deal with sovereign



citizens. Affiant stated that Affiant wasn't sovereign, Affiant's country is. Respondent #1 stated "You can go ahead and save it". "You have your opinions and beliefs and I have my opinions and beliefs". Affiant stated "They're not opinions and beliefs, they are facts". Respondent #1 threw all identification presented by Affiant onto the Police Department vehicle's hood and then proceeded to grab Respondent #1's clipboard. Respondent #1 walked back to Affiant. Affiant stated that Affiant felt he owed Respondent #1, as business etiquette, to inform Respondent #1 that Affiant is a non-U.S. citizen, non-resident alien, and that Respondent #1 may be committing an international incident. (At this time, Glendora Police Department Officer Rodriguez arrived on the scene along with two trainees).

Respondent #1 reiterated that Respondent #1 and Affiant have their own beliefs. Affiant stated that it's not beliefs, but facts. Affiant stated that even in Respondent #1's own code, 28 U.S.C. 3002, sub-section (a) the United States is a Federal corporation. Respondent #1 looked at the other officers on the scene, raised Respondent #1's arms in the air and stated, "Oh yes, I forgot, there are people out there that believe that the United States is a corporation, different from the country". Affiant stated, "Yea, I just read you the code". Respondent #1 stated, "Well Mr. Davidson, in the U.S., you are now being investigated for being under the influence". Affiant stated that Respondent #1 was committing an international incident and Respondent #1 didn't have the jurisdiction to be talking with Affiant. Respondent #1 stated that he did have jurisdiction and Respondent #1 stated that Respondent #1 was already in the middle of a full on investigation in the belief that Affiant was under the influence of amphetamine.

Respondent #1 then proceeded to conduct three field tests on Affiant:

- a) Flashlight shined into Affiant's pupils, and
- b) Laser type flashlight shined into Affiant's pupils, and
- c) Affiant was required to count to thirty, with eyes closed, and head back.

Affiant asserts that the three field tests administered by Respondent #1 were passed by the Affiant. Jessica M. Garcia was present during the administering of these tests.

4. Affiant asked Respondent #1 what Affiant's being detained, had to do with the property at 721 South Pasadena Avenue, Glendora, California. Respondent #1 didn't respond. Respondent #1 proceeded to ask Affiant the following:

- a) Did Affiant have any health issues? Affiant responded no.
- b) Did Affiant have any sinus conditions? Affiant responded no.

- c) What was Affiant's weight? Affiant responded that Affiant didn't have to answer Respondent #1's questions.
- d) What was Affiant's occupation? Affiant responded that Affiant served on the General Post Master Council and was a musician. Respondent #1 stated, "So, you're a musician"? Affiant responded again that Affiant served on the General Post Master Council and was a musician. Respondent #1 responded, "So, you're a musician".

Affiant was then placed under arrest by Respondent #1 for being under the influence of a controlled substance. Affiant was asked by Respondent #1 if Affiant wanted to say anything to Affiant's girlfriend. Affiant requested Jessica M. Garcia to call Affiant's parents and to ask Affiant's parents to call Affiant's Government. Affiant acknowledges taking Sudafed for three days, three days prior to arrest, due to a cold, but did not consider this to be a "health issue", or a "sinus condition".

While Affiant was being transferred from the site of the arrest to the Glendora Police Department location, Affiant stated to Respondent #1 that there is The United States of America and there is the corporate U.S.. Respondent #1 stated that both the Affiant and Respondent #1 could go back and forth all day on opinions and beliefs and that Respondent #1 "didn't want to hear it".

- 5. While unbuckling Affiant from back seat restraints, Respondent #1 stated to Affiant that this was the last point before entering the facility in which any narcotics found on Affiant's person, would then turn any misdemeanor into a felony. Affiant responded that Affiant had no narcotics hidden on body. Respondent #1 walked Affiant up to double doors of the building in hand cuffs. Respondent #1 informed Affiant that Affiant will be required to read a large NOTICE attached on the double doors. And, If Affiant resisted to read said NOTICE, then Respondent #1 would read the information from said NOTICE from a small card in Respondent #1's possession; then proceed with the booking process. Affiant read the NOTICE on double doors which states that any narcotics found after this point goes from a misdemeanor to a felony. Affiant did not read NOTICE out loud for Respondent #1. Respondent #1 then proceeded to open the double doors and then opened a cage door to an enclosed holding area with a counter. Respondent #1 walked Affiant into said enclosed holding area and sat Affiant down on a single bench with Affiant still in hand cuffs.

Respondent #1 stated to Affiant that it will be just a few minutes before proceeding with the processing. Respondent #1 then left the enclosed holding area. Respondent #1 then re-entered the enclosed holding area approximately twenty minutes later. Respondent #1 proceeded to conduct a full body search of Affiant. Respondent #1 instructed Affiant to please stand up and face the cage. Affiant did so. Respondent #1 then instructed Affiant that as soon as Affiant's hands were un-cuffed, Affiant was to immediately place Affiant's hands on the cage. Affiant did so. Respondent #1 then requested that Affiant sit back down. Affiant did so. Respondent #1 demanded that Affiant take off Affiant's left shoe. Affiant did so. Respondent #1 searched Affiant's entire shoe. Respondent #1 then demanded Affiant to take off Affiant's left sock. Affiant did so. Respondent #1 searched Affiant's entire sock. Respondent #1 then demanded Affiant's right shoe. Affiant complied. Respondent #1 searched the entire shoe. Respondent #1 demanded Affiant remove Affiant's right sock. Affiant did so. Respondent #1 then searched the entire sock.

6. Respondent #1 then left Affiant barefoot in the enclosed holding area for approximately ten (10) minutes. Respondent #1 then re-entered the enclosed holding area. The person identified as an Administrative Clerk, who is an elderly Caucasian woman, approached the counter and attempted three times to ask Affiant's last name, due to the noise in the enclosed holding area. Affiant responded, "DAVIDSON Comma PMA". The Administrative Clerk finally repeated "DAVIDSON Comma PMA". The Administrative Clerk stated "ok", paused and said, "What is PMA"? Respondent #1 then told the Administrative Clerk, "It's Davidson, just Davidson". Affiant then informed Respondent #1 that it is not just Davidson it's a PMA, Private Membership Association in which Affiant operates under to stay at arms-length from any entity that may try to absorb or commit violations under the Universal Declaration of Human Rights against the Affiant. Respondent #1 shrugged and stated that Respondent #1 and Affiant can go back and forth on this issue all day.

Respondent #1 demanded that Affiant follow Respondent #1 into the next room. Affiant followed Respondent #1 into the next room. Respondent #1 then told Affiant to place Affiant's feet on the feet painted on the floor. Respondent #1 then instructed Affiant to strip fully nude. Affiant complied. Respondent #1 instructed Affiant to completely lift Affiant's scrotum all the way to where buttock was visible. Affiant complied. Respondent #1 then demanded for Affiant to turn completely around and spread Affiant's buttocks and cough. Affiant complied. Affiant then turned back facing Respondent #1 and stated, "Gee, that's a hell of a job duty and description that you've got there". Respondent #1 replied that it's just part of the duty.

7. Respondent #1 asked Affiant to please get dressed. Affiant did so. Respondent #1 stated that what's next is that Affiant is going to be tested for any controlled substance in Affiant's system. Respondent #1 informed Affiant of only two options for testing; that Affiant can either take a urine test or have blood drawn from Affiant's body. Affiant stated that Affiant would like to take neither of the tests. Respondent #1 stated "so you now have refused once". Respondent #1 stated that if Affiant refused twice, then Affiant will be read from an index card by Respondent #1 and then Affiant will be held down by force, by six to seven

police officers, and Affiant's blood will be drawn from Affiant's body. Affiant, left with no choice, opted for the urine test.

Respondent #1 then walked Affiant down a hall to where bullet proof glass and steel holding cells were located. Respondent #1 opened a cell door and instructed Affiant to walk into the cell. Affiant did so. Affiant saw an old man in pain using the toilet as back support. Respondent #1 demanded that the old man move out of the way so that Affiant could proceed in taking the urine test. The old man got out of the way. The old man asked Respondent #1 if the old man could please have some food. Respondent #1 told the old man that he'd be taken care of later. Respondent #1 raised a little cup, and speaking directly to Affiant stated, "You see that gel substance at the bottom of the cup, that's just preservatives, so that the urine may be retested if need be". Respondent #1 then handed the cup to Affiant. Affiant, not having to urinate, stood at the toilet while Respondent #1 and the old man waited. Affiant, to lighten the mood, looked at the ceiling and stated, "Bottom of the ninth, three balls two strikes". Affiant was finally able to get a couple drops of urine out. Affiant asked Respondent #1, "Is that enough"? Respondent #1 looked at the cup and stated, "Um, no we're going to need a little bit more than that". Affiant turned back to the toilet and was finally able to squeeze out a couple more drops of urine. Affiant observed that there was more of what was claimed to be preservatives in the cup than there was urine. Respondent #1 accepted the urine sample and proceeded to walk Affiant back towards the enclosed holding area. Affiant asked Respondent #1 if Affiant was going to have to be in the enclosed holding area with the loud out of control drunk people for much longer. Respondent #1 answered, "You have been very cooperative, and non-problematic, and should be getting out of here within the hour". Affiant was then placed in the enclosed holding area.

8. Approximately fifteen (15) minutes later, Affiant was asked by a female officer, and the aforementioned Administrative Clerk, to exit the enclosed holding area. Affiant was again asked to stand on the painted footprints on the ground and Affiant was asked the following questions, by the aforementioned Administrative Clerk:
  - a) Was Affiant in any gangs or have gang affiliations of any kind? Affiant responded, "No".
  - b) Were tattoos on Affiant's arms gang affiliated? Affiant responded, "No".
  - c) "What is the right forearm tattoo supposed to be of, or supposed to signify"? Affiant responded, "It's a band logo".
  - d) Affiant was asked, is it a logo of a public band or is it a private logo for a band of the Affiant's? Affiant responded that it is private logo that Affiant was a band member of.
  - e) Affiant was then asked what is the tattoo on affiant's left forearm writing of and what does it say? Affiant responded that they're lyrics that Affiant wrote for one of Affiant's songs. Affiant proceeded to state from memory, "In coherent to monolithic followers. It's so easy to justify survival, and it starts right here".

Affiant was then asked, by the Administrative Clerk, to extend both arms. Affiant did so. Affiant's tattoos were photographed. Affiant was then instructed, by Administrative Clerk, to look up for a facial photo. Affiant acknowledges that Affiant attempted to make the photo unusable without being uncooperative. The Administrative Clerk stated, "If you want to get out of here, you better just look at the camera and have your photo taken". Affiant complied. Affiant stated that Affiant's "Government is just going to have to get involved".

9. Affiant was instructed, by the Administrative Clerk to lean up against the wall. The Administrative Clerk proceeded to ask Affiant the following questions:

- a) What is Affiant's full name? Affiant stated, "The I.D. says DEREK WILLIAM DAVIDSON, PMA, does it not"? The Administrative Clerk stated, "So, DEREK WILLIAM DAVIDSON". Affiant stated, "No Ma'am, its DEREK WILLIAM DAVIDSON, PMA". Affiant stated that it's an International Trust in which the Police Department, including the Administrative Clerk, are committing an International political incident, as well as, committing several Universal Declaration of Human Rights violations. The Administrative Clerk then replied that she didn't hear, or understand, a single word that Affiant had stated.
- b) Affiant was asked, "What is Affiant's social security number"? Affiant stated that Affiant does not have one. The Administrative Clerk moved on to the next question.
- c) Affiant was asked what is Affiant's occupation or career? Affiant responded that Affiant serves on The General Post Master Council for The United States of America, and that Affiant is also a professional musician. The Administrative Clerk paused and then stated out loud, "So occupation, musician".
- d) Affiant was then asked, what is Affiant's current Address? Affiant was confused by the Administrative Clerk's question. Affiant stated, "What does the International Driver License state that Affiant's address is"? Affiant then stated, " Rural Free Delivery Route 1, Box # 47, The United States of America, Global Postal Code: NAC 850H2MR7C8, does it not"? The Administrative Clerk then stated that the Administrative Clerk doesn't know, and is just going to put down 133 West Tudor Street, Covina CA, 91722. Affiant asked the Administrative Clerk, "Just what documents and I.D. are you using"? The Administrative Clerk responded that the Administrative Clerk was using the Affiant's California Driver License and records. Affiant stated, "No", one entity is a PMA and legit, and one entity is invalid and abandoned".

The Administrative Clerk then proceeded to take Affiant's right and left hand fingerprints and palm prints. The Administrative Clerk then proceeded to walk Affiant back to the enclosed holding area, where Affiant waited to sign all final documentation. Affiant was prepared to see, that all documents needing to be signed would not state the proper information that Affiant provided. So, Affiant reviewed the documents. On the **GLENDORA POLICE DEPARTMENT, East District West Covina Court, NOTICE TO APPEAR G403680** dated 04/17/16, Affiant placed a comma and PMA at the end of the pre-printed "(First, Middle, Last)" name . Affiant signed "Derek William Davidson, Trustee" on the signature line of this

same document. The Administrative Clerk, seeing Affiant sign, stated that no one really sees these forms any way so Affiant didn't need to do that. Affiant stated, "That's nice. I read every word on the page before I sign anything". Affiant was then released from custody. Affiant's shoes and documentation were returned to Affiant. The Administrative Clerk asked Affiant if there was anything else the station could help Affiant with? Affiant stated that Affiant needed the business cards of both the arresting officer and the Watch Commander. The Administrative Clerk provided Affiant with both business cards. Affiant exited via the front door

## **Complaint**

Affiant alleges that the following human rights violations occurred within the Universal Declaration of Human Rights:

### **1. Article-3**

- Everyone has the right to life, liberty and security of person.

### **2. Article-4**

- No one shall be held in slavery or servitude; slavery and the slave trade shall be prohibited in all their forms.

### **3. Article-5**

- No one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment.

### **4. Article-9**

- No one shall be subjected to arbitrary arrest, detention or exile.

### **5. Article-12**

- No one shall be subjected to arbitrary interference with his privacy, family, home or correspondence, nor to attacks upon his honour and reputation. Everyone has the right to the protection of the law against such interference or attacks.

### **6. Article-15**

- (1) Everyone has the right to a nationality.

- (2) No one shall be arbitrarily deprived of his nationality nor denied the right to change his nationality.

## 7. Article-30

- Nothing in this Declaration may be interpreted as implying for any State, group or person any right to engage in any activity or to perform any act aimed at the destruction of any of the rights and freedoms set forth herein.

## Remedy

1. An INTERNATIONAL COMPLAINT filed with the Department of Defense.
2. Quash **GLENDORA POLICE DEPARTMENT, East District West Covina Court, NOTICE TO APPEAR G403680** dated 04/17/16, all charges and any court case(s), related to Affiant.
3. Expunge all of Affiant's records related to this case.
4. Quash all administrative costs charged to Affiant by THE CITY OF GLENDORA, Glendora Police Department.
5. Investigate THE CITY OF GLENDORA, Glendora Police Department for human trafficking and kidnapping.

The affiant further sayeth naught.



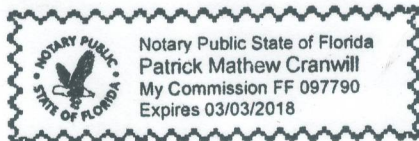
