The company has been doing business as government which is neither a defacto nor dejure National Government, and is not Government itself. Its long line of presidents have all been linked to or related to George Washington as his heirs to operating his private oligarchy and not a National Government. Therefore, it is not with any right or privilege to advertise itself as a National Government or speak on behalf of the country as a National Government.

The city of Washington D.C. was formed into a city-state wherein the 50 state representatives convene to discuss the business of each state and oligarchy business, not National Government business. It is reported that the states formed a union under the constitution of the United States of America, an entity that names Prince George, III as "arch-treasurer and prince elector".

It having pleased the Divine Providence to dispose the hearts of the most serene and most potent Prince George the Third, by the grace of God, king of Great Britain, France, and Ireland, defender of the faith, duke of Brunswick and Lunebourg, arch-treasurer and prince elector of the Holy Roman Empire etc., and of the United States of America. (The Treaty of Paris, 1783)

That particular constitution of the United States of America was not in existence in the year 1783. Therefore, the states could not have ratified that treaty. One can only conclude that the treaty was formed as a treaty with England that treated with a company it owned— the British East India Trading Company— a franchise of the East India Trading Company owned by the Dutch.

The country known as The United States of America

That is six different entities in a 200 year period created by the oligarchy. Name changes have been used nefariously to create confusion and agitate the people and to give the people the illusion of representation.

Correcting the Past

The first thing the American Nationals had to do was sign the Declaration of Independence. Next was to sign the Articles of Confederation of 1781, claim it, issue notice and wait 90 days for any objections. As there were no objections, authority to revamp the original Government passed to the American Nationals.

Why the confederacy of 1781? It is because it was the only government that was voted in by all 13 independent states. Further, the original General Post Office was at stake. When Governments fall, all offices and every attribute of that Government reverts back to the General Post Office from whence it came.

Once American Nationals were parties to those agreements, the Declaration of Independence gave them the authority to change government:

"That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness."

American Nationals found some discrepancies. Whenever someone changes an entity, in order for the former entity to retain the rights of the present entity, it shall read "as amended". Thus, when the first entity, the thirteen united States of America was created, and in the same document it read the united States of America, it should have read: "the united States of America, as amended, then in the Articles of Confederation of 1781, altogether, it should of read: The Stile of this Confederacy shall be: the thirteen united States of America, as amended to "the united States of America" as amended to "the United States of America".

Now the Confederacy has a Declaration of Independence, and the Declaration of Independence is legally connected to a Government. This discrepancy was corrected by the current American Nationals in the Articles of Confederation as amended during a constitutional convention held by the Confederation Party as amended to the North American National Party.

The discrepancies should have been corrected in the constitutional convention of 1787, however, that was not on the agenda of George Washington and his allies of Europe.

The second issue was found in 1783 in the Treaty of Paris: "It having pleased the Divine Providence to dispose the hearts of the most serene and most potent Prince George the Third, by the grace of God, king of Great Britain, France, and Ireland, defender of the faith, duke of Brunswick and Lunebourg, arch-treasurer and prince elector of the Holy Roman Empire etc., and of the United States of America."

Where did this new country come from that made an enemy of the Confederacy its Arch Treasurer? The answer is: it didn't. King George was treating with his own company and placed himself as Arch Treasurer.

Then the same king started naturalizing people as citizens of the United States requiring white males only as part of the naturalization qualifications. King George had Alexander Hamilton establish, a year after the Treaty of Paris, the Bank of New York in 1784. The Bank of New York is now doing business as The Bank of New York Mellon in the foreign country of Manhattan Island under Dutch rule.

King George claimed the same territory that was at the disposal of the Confederacy of 1781 and started monetizing. The Masons started this alleged "new government" for King George. The same entity "the United States of America" still treats with the Vatican and the Crown. The Monarch of England continues to treaty with itself.

Here is how the "Grand Constitutional Convention" played out: The Masons came together, in the name of their king, the Vatican, and the city of London, under the premise of amending the Articles of Confederation. However, when the convention ended, George Washington signed the 1789 Constitution with 39 delegates as witnesses. This is significant as the Articles of Confederation, under Article XIII, required 74 delegates for amendment otherwise the document could not undergo amendment. Thus, a proper amendment to the Articles of Confederation never occurred. A new document, the constitution, usurped the authority of the Articles of Confederation having been advertised as a National Government even though it did not qualify as defacto or dejure government.

No one else has ever signed the 1789 constitution, so no one else is a party to it. The entity within that constitution is the United States of America. Interestingly, research seems to establish that each president from George Washington forward, has been a relation to George Washington, as well as a Mason. Private membership associations cannot claim government powers and authority outside of the association.

Today, the only way out of this web of illusion is to declare exile and proclaim the existence of a new nation or declare exile and declare the existence of the original abandoned Government, fix its legal problems and correct the historical record. American Nationals decided to honor the 650 thousand people that died to establish the country at that time. The American Nationals corrected the chain of title to the country and fulfilled the constitutional convention as it was intended by the revolutionaries to amend the Articles of Confederation into a National Government.

In order to bind your person within that nation is through an oath or affirmation to that nation which is called the set apart spirit in the Scriptures.

The nation must have a General Post Office. It also required many offices that the original Articles of Confederation did not establish. Thus, it was properly amended in August of 2015.

Then the only way into the original independent states was through The United States of America because it was an inter-governmental organization of independent states that had power of attorney for the States when dealing in foreign affairs. It was also the original Union of people within those independent states. According to the Articles of Confederation, the people were in Union and the states were in league known as a league of friendship.

The United States of America was still classified as a central Government and therefore has a right to speak on behalf of the country. The Government of The United States of America has the legal right to regulate Interstate Commerce as the National Government.

Since the .gov top level domain falls under National Government and not a federal union of states also known as a union of private companies, the Government of The United States of America has the right to govern the .gov top level domain and regulate it.

The federal union of states also known as U.S. states are issuing private companies the .gov domain name that are not with the right to issue obligations, bonds, security instruments and a host of judgments, orders and indictments outside of their organizations against the General Public. Those private companies do not exist within National Government authority and cannot advertise themselves as a government entity.

GSA is violating every Article of the Universal Declaration of Human Rights and every Article of the Convention of the Rights of the Child adopted by the Government of The United States of America. The private companies do not have any authority to speak for the United States that resides within the Government of The United States of America. All obligations from those private companies are null and void regardless if the states within the federal union agreed or not through separate compact agreement under the company Articles known as the constitution of the United States. Either way, a private company is not with the authority to operate as a government and the States should have known to correct this serious legal conflict.

A State does not derive its authority from other states, it derives its authority from the people wherein is the conflict of the law of nations that GSA implements on a daily basis. GSA has consistently failed to distinguish whether or not the entity that received the .gov domain was a government voted into existence by the people or a self interested private company.
