On the **302<sup>nd</sup> day** in the year of our Creator **6021**, at **7:15 UTC-6**, translated January 14<sup>th</sup>, 2020 the American Nationals and Declared Residents for The United States of America, and all other interested persons convened an assembly for the American National Union of The United States of America, identified as **20200114-GC-OAR**.

**BE IT RESOLVED**, motion to accept 'First Union Defenders' as the style of the entity used within the Articles of Association for the American National Union Police Department; and

**BE IT RESOLVED**, that a motion was carried to pass the following reservation of rights within the American National Union of The United States of America (hereinafter "ANU") as an education tool; and

The ANU to reserve the rights for its members to travel the public road unhindered and unmolested.

The ANU reserves the right to protect the intellectual property rights of its members upon appointment and claim(s).

The ANU reserves the right to protect its members from any removal of bodily fluids such as blood, saliva, hair, urine, feces or any dismemberment of the human body including skin.



The ANU reserves the right to protect its member's rights to not be subjected to forceful injections, forceful medications and any other substance the member reserves the right not to be put in their body.

The ANU reserves its rights to not have any data collection such as fingerprints, handprints, footprints, pictures, blood type and DNA.

The ANU reserves the right upon appointment and claim from any of its members to publish correcting of any record for libel.

The ANU reserves its rights to protect its member('s) intangible rights to convey or move any private real property in their private automobiles. Private property to also include guns in any shape, form or capacity.

The ANU reserves the right upon appointment and claim to charge any foreign association with war crimes for any psychological experimentation of its member(s).

**FURTHER BE IT RESOLVED**, that a motion was passed that the American National Union of The United States of America hereby reserves the right to amend and add further reservation of rights in the future as deemed appropriate by this body under the By-Laws of the Constitution of the American National Union of The United States of America; and

**BE IT RESOLVED**, the meeting for the assembly of the American National Union of The United States of America adjourned on this 302<sup>nd</sup> day in the year of Yahweh, six thousand and twenty-one, and the 14<sup>th</sup> day of January in the two thousand and twentieth year of the new covenant in Yahushua's name, at **8:56 Universal Time -6** to re-convene at a future date certain.


