On the **195<sup>th</sup> day** in the year of our Creator **6022**, at **7:37 UTC-6**, translated September 29<sup>th</sup>, 2020 the American Nationals and Declared Residents for The United States of America, and all other interested persons convened an assembly for the American National Union of The United States of America, identified as **20200929-GC-OAR**.
