COMES NOW, the undersigned International Notary, serving as the Notary Presenter for the Human Rights Defenders for the Government of The United States of America, hereinafter Publisher, who certifies that the Proclamation of Involuntary Dissolution, naming Nancy Doty and the National Guardianship Association, was published under INTERNATIONAL NOTICES in the American Herald newspaper, and in Scribd under Legal Forms, on September 17th, 18th, 19th, and 20th, 2015.

This CORRECTION BY PUBLICATION of a previously published Proclamation is made to correct a clerical error made by this International Notary. In the previously published presentment, the second publishing had in it a different entity whereby the Respondant's name was changed by the substitution of a single letter (a typo). This mistaken identity was then carried forward in subsequent publishings and in the Publisher's Affidavit. There was no reason or intent to do harm and this Notary believes the nature of the error is clear evidence of that fact. Today, November 2, 2015, begins the re-Publication for three (3) consecutive days of that Proclamation to cure this defect.

PROCLAMATION OF INVOLUNTARY DISSOLUTION

It is hereby proclaimed by the United States, in Congress assembled, acting under the authority of the **Involuntary Dissolution Act of 2015** that;

WHEREAS the National Guardianship Association, (hereinafter, "Association") has violated and continues to violate multiple articles of the Universal Declaration of Human Rights, and

WHEREAS the Association, having exceeded the maximum time allotted to cure the aforementioned human rights violations, and

WHEREAS Nancy Doty has not been held accountable for her crimes against humanity within the local political subdivision of the State of Oregon, and

WHEREAS the Association continues to operate within the metes and bounds of The United States of America with intent to continue to violate the Universal Declaration of Human Rights and commit further crimes against humanity, and

BE IT RESOLVED that the Association and its Articles are hereby Dissolved, and

FURTHER BE IT RESOLVED that Nancy Doty is under arrest and sentenced to incarceration for a term no shorter than 30 years under permanent dissolution of NANCY DOTY INC.; or any other entity created by Nancy Doty to continue to commit multiple human rights violations against "senior citizens" of the American Society, and

BE IT SO ORDERED by the United States, in Congress assembled this 17th day of the 9th Month in the year 2015,

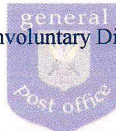
