### INTERNATIONAL FOREIGN CURRENCY EXCHANGE LICENSE AGREEMENT FOR CONTINENTAL PUBLIC BANK

This International Foreign Currency Exchange License Agreement (hereinafter, “*License Agreement*”) is made on September 1st, 2016 between the **office of the Treasury for the Government of The United States of America**, herein referred to as the “*Licensor*”, whose address is RR 1, Box #7, The United States of America, NAC: 850H2 MR7C8 and **Continental Public Bank**, herein referred to as the “*Licensee*”, whose address is RR1, Box #77, The United States of America, NAC: 850H2 MR7C8. Both parties have discussed all details in the agreement and have decided to enter into this contract with mutual consent, the particulars of which are as follows:

#### LICENSED MATERIAL – COPYRIGHT AND TRADEMARK USE

1. The Licensee having completed all formalities in accordance with this License Agreement will have non-exclusive rights to use the Licensed Material which is the Continental Dollar in the form of legal tender for debts public and private in accordance with the *Legal Tender for Debts Public and Private Act of 2016*; and
2. All License Agreements by and large require the Licensee and the authorized users if any to comply with the terms and conditions set forth in the agreement; and
3. The copyright, title and trademark of the Licensed Material will remain with the Licensor; and

4. North American National Party will have the right to specify every now and then how its trademark should be used; and

#### **LICENSE PERIOD – TERM & TERMINATION**

1. This License Agreement shall be valid for four (4) years, beginning September 1st, 2016; and
2. The License shall terminate on September 1st, 2020; and
3. Both parties may terminate this agreement with a prior notice of thirty (30) days before the decided termination date; and
  - a) However, the Licensor holds the right to abruptly terminate the contract before the termination period if the Licensee, after signing the contract refuses to comply with any of the terms and condition set forth in the License Agreement; and
4. Upon termination of this contract, as is common with all License Agreements, all rights granted in this License Agreement will be non-existent; and

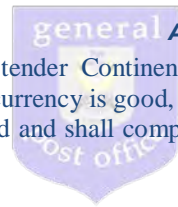
#### **RENEWAL**

1. All License Agreements are renewable upon termination of the contract unless either party gives a written notice regarding non-renewal of the License; and

#### **FEES**

1. The Licensee shall pay a total amount of +1.00 to the Licensor for the use of the licensed material; and

1. The exchange provider presents the legal tender Continental Dollar (UCD) available for exchange with other currency's and warrants that the exchanged currency is good, clean, clear, of non-criminal origin, free from any liens and taxes, freely transferable to be transacted and shall comply with the Anti Money Laundering Policy of General Post Office Division 3; and



#### **AUTHORIZED USER CONDITIONS**

1. The Continental Dollar provider presents the legal tender Continental Dollar (UCD) available and warrants that they are good, clean, clear, of non-criminal origin, free from any liens and taxes, freely transferable to be transacted; and
2. The Licensor as in all License Agreements assures to the Licensee that any use of the Licensed Material by the Licensor and the Authorized Users will not harm any third party nor will it violate the international copyright laws; and

#### **WARRANTY ASSURANCE**

1. Either party will not hold the other responsible for any loss, damage or injuries that has been sustained by any third party; and

#### **LOSSES AND DAMAGES**

#### **DELAY IN ACQUIRING LICENSE**

1. The Licensee shall not hold the Licensor responsible in any way for the default or delay in acquiring the License if the default/delay is due to any external factors – Government orders, or natural conditions that might interfere with acquiring License; and

#### **AMENDMENT/WAIVER**

1. No amendment or waiver of any fees listed in the agreement is possible unless agreed by the Licensor in writing; and

#### **ADDITIONAL LICENSES**

1. Any additional License relating to the agreed upon Licensed Material OR the Licensee's service area can be issued from time to time by the Licensor; and



- a) However, this will be agreed upon in writing by the Licensor; and
- b) This agreement as all other License Agreements has been agreed upon by both the Licensor and the Licensee; and
