On the 8th day of **July** in the year **2015**, at 7:00 PM Central, The Nationals and RESIDENTS for The United States of America, and all other interested persons convened a meeting for the assembly, identified as **20150708-SOS-OAR**.

Official Assembly Record

WHEREAS, many U.S. states are in a budget crisis and a majority of states are making cuts, wherein the assembly of affirmed American Nationals may offer resources within the office of the Treasury for The United States of America in the form of Continental Dollars to help offset the budget; and

BE IT RESOLVED, that a motion was carried by the affirmed American Nationals to offer the U.S. states Continental Dollars as required to offset the budget; and

WHEREAS, the Department of State, a department within the office of the Secretary of State for The United States of America is without an import or export form; and

BE IT RESOLVED, that a motion was carried by the affirmed American Nationals hereby adopt the Import form (*Importation of Motor Vehicles and Motor Vehicle Equipment Subject to Federal Motor Vehicle Safety, Bumper and Theft Prevention Standards*) HS79710 and amend as required; and

FURTHER BE IT RESOLVED, the affirmed American Nationals hereby adopt the Export form (*SHIPPER'S EXPORT DECLARATION*) form 7525-V and amend as required; and

WHEREAS, currently the right of the affirmed American Nationals to authorize the Government for The United States of America to lease property on the behalf of affirmed American Nationals and to accept cash and tangible or intangible property contributions from affirmed American Nationals or other source does not exist; and

BE IT RESOLVED, that a motion was carried by the affirmed American Nationals to petition the United States, in Congress assembled, to Accept and Acknowledge the **AUTHORITY TO LEASE AND ACCEPT PROPERTY ACT OF 2015**; and

WHEREAS, currently the GPEX website does not offer account users access to the website via an app for smartphone devices; and

BE IT RESOLVED, that a motion was carried by the affirmed American Nationals to create an app for account users on the GPEX website for access on smartphone devices; and

WHEREAS, the assembly of The United States of America has no further matters to consider and act on; and

BE IT RESOLVED, the meeting for the assembly adjourned on this 8th day of **July in the year 2015**, 8:35 PM to re-convene at a future date certain.
