The Head of the committee for the Bank of North America has accepted and acknowledged the transfer of all banking decisions and all powers from the Government committee to the committee for the Bank of North America on the 7th day of September in the year 2015 under the Charter Accepted and acknowledged this 9th day of June 2015; and

The Head of the committee for the Bank of North America has completed its bank manual which are the terms and conditions of its license to issue the Continental Dollar as a National currency; and

FURTHER, the Superintendent of Finance for the Bank of North America is now known as the Superintendent of Finance for GPOD3; and

FURTHER, the Public Bank of the Government of The United States of America seal shall be transferred from:




