THE GREAT SEAL OF THE REFORMED GOVERNMENT OF THE UNITED STATES OF AMERICA, 1781; BROUGHT FORWARD TO THE PRESENT TIME

WHEREAS, Quote "On July 4, 1776, the same day that independence from Great Britain was declared by the thirteen states, the Continental Congress named the first committee to design a Great Seal, or national emblem, for the country. Similar to other nations, the United States needed an official symbol of sovereignty to formalize and seal (or sign) international treaties and transactions. It took six years, three committees, and the contributions of fourteen men before the Congress finally accepted a design (which included elements proposed by each of the three committees) in 1782.[10]" End Quote; and

WHEREAS, Quote "The first committee consisted of Benjamin Franklin, Thomas Jefferson, and John Adams.... Each of these men proposed a design for the seal." End Quote; and

WHEREAS, Quote "Franklin chose an allegorical scene from Exodus, described in his notes as "Moses standing on the Shore, and extending his Hand over the Sea, thereby causing the same to overwhelm Pharaoh who is sitting in an open Chariot, a Crown on his Head and a Sword in his Hand. Rays from a Pillar of Fire in the Clouds reaching to Moses, to express that he acts by Command of the Deity." Motto, "Rebellion to Tyrants is Obedience to God."":

*Moses, standing on the shore, and extending his hand over the sea, thereby causing the same to overwhelm Pharaoh who is sitting in an open Chariot, a Crown on his Head & a Sword in his Hand. Rays from a Pillar of Fire in the Clouds reaching to Moses, to express that he acts by the Command of the Deity.
Motto, Rebellion to Tyrants. Obedience to God.*

WHEREAS, Quote "On August 20, 1776, the committee presented their report to Congress. The committee members chose Du Simitière's design, though it was changed to remove the anchor of hope and replace the soldier with Lady Justice holding a sword and a balance. Surrounding the main elements was the inscription "Seal of The United States of America MDCCLXXVI". For the reverse, Franklin's design of Moses parting the Red Sea was used. Congress was however not impressed, and on the same day ordered that the report "lie on the table", ending the work of the committee.[17]" End Quote; and

WHEREAS, Quote:



"Franklin's design was recommended by the first committee for the reverse side of the Great Seal. No sketch was made of their design. The above drawing was made by Benson J. Lossing for Harper's New Monthly Magazine in July 1856. Note: Lossing failed to include something Franklin specified: "Rays from a Pillar of Fire in the Clouds reaching to Moses." End Quote; and

WHEREAS, the people for The United States of America, affirmed American Nationals in their own right and proper standing as required by the Law of Nations, declared that the original United States, in Congress assembled, 1781, was hereby declared abandoned in 1789, along with the original perpetual Union; and

WHEREAS, it was declared that The United States of America shall continue to function as a Government of The United States of America, re-started and claimed in 2010 to present time and thereby restoring the chain of title for The United States of America; and

WHEREAS, the people for The United States of America, affirmed American Nationals, enacted THE PERPETUAL DISHONOR, TREASON, ABANDONMENT AND DISSOLUTION ACT OF 2013, on the 21st day of January, 2013; and

WHEREAS, it was further declared that all of the original thirteen States are relieved of duty and perpetual obligation to the original perpetual Union of The United States of America and the perpetuity was hereby transferred to the existence of The United States of America as an Independent Nation of the living and honorable completely acknowledged and recognized by the reign of the heavens; and

WHEREAS, the Great Seal for the Government for The United States of America has been adopted as the official symbol of this Government to formalize and seal (or sign) international treaties and transactions; and

WHEREAS, the Great Seal for the Government for The United States of America has been amended; and



WHEREAS, any and all claims under the original adopted Great Seal have been transferred to the current Great Seal, and have not been changed nor altered in any way for chain of title purposes and therefore the title is clear and correct; and

GREAT SEAL DETAIL REPORT

Problem #1 - Raster graphics

The current digital image for the Great Seal is available in only “.png” and/or “.bmp” file format; which is unusable for printing high quality images, on the flag for The United States of America, patches, diplomatic pouch on leather bound portfolio, etc.

“JPEG”, “GIF”, and “BMP” image files are prone to pixelate regardless of the resolution of the image, making them difficult to work with when resizing. A more suitable file to use for the purposes of print production is a vector graphic file.

Because vector-based images are not made up of a specific number of dots, they can be scaled to a larger size and not lose any image quality. When you resize a raster graphic to a larger size/resolution, it appears “blocky”, or “pixelated.” When you resize a vector graphic, the edges of each object within the graphic stay smooth and clean.

Unlike “JPEG”, “GIF”, and “BMP” images, vector graphics are not made up of a grid of pixels. Instead, vector graphics are comprised of paths, which are defined by a start and end point, along with other points, curves, and angles along the way. This is what makes a vector graphic the ideal file format for commercial print production purposes.

Solution:

Create a vector graphic image of the final amended Great Seal.

Problem #2 – Creating a vector file would significantly alter the Great Seal image.

To our knowledge and belief, a vector file for the Great Seal does not exist.

In addition, a unique image of the Great Seal for Government of The United States of America does not exist. All available images of the Great Seal are limited to the three aforementioned images.

Solution:

Use the opportunity to amend the Great Seal per the following proposed suggestions for the purposes of maintaining chain of title, print production, and a unique Great Seal image for the Government of The United States of America.

Problem #3 - Color system

For purposes of consistent print production in whatever format and scale, the Great Seal is without a color system to define and maintain a uniform color coding system.

Solution:

1. Use and specify the “The PANTONE MATCHING SYSTEM®.
2. Both the RGB color system and PANTONE Colors can be specified for the application of different use/print processes.

BE IT RESOLVED, that the Great Seal is amended and brought forward to the present time with all rights, title, interest, claims, laws, acts, and statutes and any other claims, documents, writings, pictures and any other words claimed under the original Great Seal is hereby transferred to this Great Seal and under the amended wording.
