### GRANT DEED



Summary:

The UNITED STATES, a private trust operating as a private membership association incorporated on behalf of the US CITIZENS. The UNITED STATES is involved with multiple human rights violations, engaging in blatant commercial discrimination and trafficking persons while displaying to the public that the trafficked persons are members of the UNITED STATES and obligated to the trustees and the trustees policies, statutes and procedures thereby forming a legal box of entrapment, and

Therefore, under the doctrine of necessity, the following grant deed shall serve to correct the multiple human rights violations, blatant commercial discrimination, trafficking of persons, perpetual arrest, perpetual detainment and perpetual exile as it pertains to the U.S. CITIZEN, and

The UNITED STATES is in violation of Article 9 of the Universal Declaration of Human Rights (UDHR). The UNITED STATES through its subsidiaries made an arbitrary arrest of the U.S. CITIZEN upon its creation and is currently detaining it for an unknown period of time thereby using it against the human being as a perpetual weapon.

Further, the UNITED STATES has blocked any form of access to any court for the life or liberty of the U.S. CITIZEN. The U.S. CITIZEN has been exiled from any form of equality before the law, access to government, any form of un-encumbered political process and thereby causes a perpetual form of torture that is on going from the UNITED STATES against the U.S. CITIZEN. The inhumane treatment enforced by the UNITED STATES does not display any form of the characteristics of a human being that is required by human beings entrusted with its welfare in violation of Article 4 and 5 of the UDHR.
