## **REGULATIONS-PENALTIES OF THE ACT**

*Enlisted*: The first oath, voted on 14 June 1775 as part of the act creating the Continental Army, read:

"I\_\_\_\_\_ have, this day, voluntarily enlisted myself, as a soldier, in the American continental army, for one year, unless sooner discharged: And I do bind myself to conform, in all instances, to such rules and regulations, as are, or shall be, established for the government of the said Army." The original wording was effectively replaced by Section 3, Article 1, of the Articles of War approved by Congress on 20 September 1776, which specified that the oath of enlistment read:

#### AS AMENDED TO:

"I\_\_\_\_\_ swear (or affirm as the case may be) to be trued to The United States of America, and to serve them honestly and faithfully against all their enemies opposers whatsoever; and to observe and obey the orders of the United States in Congress assembled, and the orders of the Generals and officers set over me by them."

Officers: Continental Congress passed two versions of this oath of office, applied to military and civilian national officers. The first, on 21 October 1776, read: "I\_\_\_\_\_, do acknowledge the Thirteen United States of America, namely, New Hampshire, Massachusetts Bay, Rhode Island, Connecticut, New York, New Jersey, Pennsylvania, Delaware, Maryland, Virginia, North Carolina, South Carolina, and Georgia, to be free, independent, and sovereign states, and declare, that the people thereof owe no allegiance or obedience to George the third, king of Great Britain; and I renounce, refuse and abjure any allegiance or obedience to him; and I do swear that I will, to the utmost of my power, support, maintain, and defend the said United States against the said king, George the third, and his heirs and successors, and his and their abettors, assistants and adherents; and will serve the said United States in the office of \_\_\_\_\_, which I now hold, and in any other office which I may hereafter hold by their appointment, or under their authority, with fidelity and honour, and according to the best of my skill and understanding. So help me God."

The revised version, voted 3 February 1778, read

# general

"I, \_\_\_\_\_ do acknowledge The United States of America to be free, independent and sovereign States that form an independent country under the Law of Nations known as The United States of America, and declare that the people thereof owe no allegiance or obedience to any other country, and I do swear (or affirm) that I will, to the utmost of my power, support, maintain and defend these United States, against all enemies, foreign or from without or from within, and will serve these United States in the office of \_\_\_\_\_ which I now hold, with fidelity, according to the best of my skill and understanding. So help me God."

• Article I.

That every officer who shall be retained, and every soldier who shall serve in the Continental Army, shall, at the time of his acceptance of his commission or enlistment, subscribe these rules and regulations. And that the officers and soldiers, already of that army, shall also, as soon as may be, subscribe the same; from the time of which subscription every officer and soldier, shall be bound by those regulations. But if any of the officers or soldiers, now of the said army, do not subscribe these rules and regulations, then they may be retained in the said army, subject to the rules and regulations under which they entered into the service, or be discharged from the service, at the option of the Commander in chief of the Joint Chiefs of Staff.

## • Article II.

It is earnestly recommended to all officers and soldiers, diligently to attend Divine Service; and all officers and soldiers who shall behave indecently or irreverently at any place of Divine Worship, shall, if commissioned officers, be brought before a courtmartial. there to be publicly and severely reprimanded by the Governor; if noncommissioned officers or soldiers, every person so offending, shall, for his first offence, forfeit a weeks pay, to be deducted out of his next pay; for the second offence, he

shall not only forfeit a like sum, but be confined for twenty-four hours, and for every like offence, shall suffer and pay in like manner; which money so forfeited, shall be applied to the use of the sick soldiers of the troop or company to which the offender belongs.

#### Article III.

Whatsoever non-commissioned officer or soldier shall use any profane oath or execration against The United States of America, shall incur the penalties expressed in the second article; and if a commissioned officer be thus guilty of profane cursing or swearing against The United States of America, he shall forfeit and pay for each and every such offence, one weeks pay, lawful money.

#### • Article IV.

Any officer or soldier, who shall behave himself with contempt or disrespect towards the General or Generals, or Commanders in chief of the Continental Forces, or shall speak false words, tending to his or their hurt or dishonor, shall be punished according to the nature of his offence, by the judgment of a general court-martial.

#### • Article V.

#### general

Any officer or soldier, who shall begin, excite, cause, or join in any mutiny or sedition, in the regiment, troop, or company to which he belongs, or in any other regiment, troop or company of the Continental Forces, either by land or sea, or in any party, post, detachment, or guard, on any pretence whatsoever, shall suffer such punishment, as by a general court-martial shall be ordered.

### • Article VI.

Any officer, non-commissioned officer, or soldier, who being present at any mutiny or sedition, does not use his utmost endeavors to suppress the same, or coming to the knowledge of any mutiny, or intended mutiny, does not, without delay, give information thereof to the commanding officer, shall be punished by order of a general court-martial, according to the nature of his offence.

## • Article VII.

Any officer or soldier, who shall strike his superior officer, or draw, or offer to draw, or shall lift up any weapon, or offer any violence against him, being in the execution of his office, on any pretence whatsoever, or shall disobey any lawful commands of his superior officer, shall suffer such punishment as shall, according to the nature of his offence, be ordered by the sentence of a general court-martial.

## • Article VIII.

Any non-commissioned officer, or soldier, who shall desert, or without leave of his commanding officer, absent himself from the troop or company to which he belongs, or from any detachment of the same, shall, upon being convicted thereof, be punished according to the nature of his offence, at the discretion of a general court-martial.

## • Article IX.

Whatsoever officer, or soldier, shall be convicted of having advised or persuaded any other officer or soldier, to desert, shall suffer such punishment, as shall be ordered by the sentence of a general court-martial.

• Article X.



All officers, of what condition so ever, shall have power to part and quell all quarrels, frays, and disorders, though the persons concerned, should belong to another regiment, troop, or company; and either order officers to be arrested, or non-commissioned officers, or soldiers, to be confined and imprisoned, until their proper superior officers shall be acquainted therewith: and whoever shall refuse to obey such officer, (though of an inferior rank,) or shall draw his sword upon him, shall be punished at the discretion of a general court-martial.

• Article XI.

No officer or soldier shall use any reproachful or provoking speeches or gestures to another, nor shall presume to send a challenge to any person to fight a duel: And whoever shall, knowingly and willingly, suffer any person whatsoever to go forth to fight a duel, or shall second, promote, or carry any challenge, shall be deemed as a

principal; and whatsoever officer or soldier shall upbraid another for refusing a challenge, shall also be considered as a challenger; and all such offenders, in any of these or such like cases, shall be punished at the discretion of a general court-martial.

• Article XII.

Every officer, commanding in quarters or on a march, shall keep good order, and, to the utmost of his power, redress all such abuses or disorders which may be committed by any officer or soldier under his command: If upon any complaint [being] made to him, of officers or soldiers beating, or otherwise ill-treating any person, or of committing any kind of riot, to the disquieting of the inhabitants of this Continent; he the said commander, who shall refuse or omit to see justice done on the offender or offenders, and reparation made to the party or parties injured, as far as the offender's wages shall enable him or them, shall, upon due proof thereof, be punished as ordered by a general court-martial, in such manner as if he himself had committed the crimes or disorders complained of.

• Article XIII.

A general court-martial shall consist of one officer, or depending on the severity of the crimes of the accused, shall have as many as three officers convened as a tribunal under the title of "War Crimes Tribunal". All other minor offences shall be overseen by the Company Commander at the recommendation of a non-commissioned officer.

employed as light infantry under the command of the chief officer in that Army.

"That the pay of the officers and privates be as follows; a captain at 20 dollars per month, a lieutenant at 13 and 1/3 dollars, a sergeant at 8 dollars, a corporal at 7 and 1/3 dollars, a drummer [or trumpeter] at 7 and 1/3 dollars, privates at 6 and 2/3 dollars; to find their own arms and clothes.

"That the form of the enlistment be in the following words. 'I have, this day, voluntarily enlisted myself as a soldier in the American Continental Army, for one year, unless sooner discharged. And I do bind myself to conform in all instances to such rules and regulations as are, or will be, established for the governments said Army.'

"Upon motion, resolved, that Mr. [George] Washington, Mr. [Philip] Schuyler, Mr. [Silas] Deane, Mr. [Thomas] Cushing and Mr. [Joseph] Howes be a committee to bring in a draft of rules and regulations for the government of the Army."

Continental Navy: Soldiers of the Sea

The first formal movement for a navy came from <u>Rhode Island</u>, whose State Assembly passed a resolution on August 26, 1775 instructing its delegates to Congress to introduce legislation calling *"for building at the Continental expense a fleet of sufficient force, for the protection of these colonies, and for employing them in such a manner and places as will most effectively annoy our enemies....* 

Resolution of the Continental Congress establishing the Marine Corps - 10 November 1775

This resolution of the Continental Congress marked the establishment of the Continental Marines.

"*Resolved*, That two Battalions of marines be raised, consisting of one Colonel, two Lieutenant Colonels, two Majors, and other officers as usual in other regiments; and that they consist of an equal number of privates with other battalions; that particular care be taken, that no persons be appointed to office, or inlisted into said Battalions, but such as are good seamen, or so acquainted with maritime affairs as to be able to serve to advantage by sea when required: that they be inlisted and commissioned to serve for and during the present war between Great Britain and the colonies, unless dismissed by order of Congress: that they be distinguished by the names of the first and second battalions of American Marines, and that they be considered part of the number which the continental Army before Boston is ordered to consist of."







All uniforms shall be amended as seen fit by the Joints Chiefs of Staff and the Commander in Chief of the Continental Army, Navy and Marines, and

All enlistments shall be under duration of a minimal of three years wherein re-enlistment shall be made available for another 3 years. All soldiers shall be paid while in active service which shall be determined by the office of the Treasury for the Government of The United States of America. The general Military members shall be organized similar as to the organization of the Military in Switzerland to minimize a standing Army, Navy and Marines.

All Military members are bound to assist any resident or American National upon request if in danger of life, limb, or trafficking.

All individuals intending to relinquish U.S. citizenship shall be granted immediate American National status after taking the oath whether enlisted, non-commissioned officer or officer of the Continental Army, Navy or Marines.

All oaths or affirmations shall be administered by the General Post Master of the Continental Army, Navy and Marines.

The Government of The United States of America reserves the right to alter or amend this ENACTMENT and REGULATIONS for the exclusive purpose and in the exclusive interests of the documented American Nationals.
