## Amend the Articles of the Association 1774

As Bailor and Representing The Republic States within The United States of America 1781 proper, within specifically established metes and bounds currently State nationalized, and of many delegated to Amend The Articles of the Association 1774, under the 1781 Perpetual Union of States, within The United States of America, Comes John Rowe PMA and Private Attorney General's Across America as Trustee, in hand and seal and under residency therein, states the following: Submitted before the National assembly is an compilation of recommendations made by survey as set forth and sponsored by the General Post Office:

## The Articles of Association, October 20, 1774; as amended May 15<sup>th</sup>, 2017

This tendered, these The Articles of Association 1774 is of a bygone era; and hereby is amended, and is moved to be Internationally listed, therefore amending and delegating jurisdiction in National Law subject to other Treaty's and Associations whereby created.

The Articles of Association for the Union have long been applied for the purpose of perpetual war by the many sides and speculators of that era of time and between the Monarchs private companies and this Union. The point of view by and between both parties have remained within opposite spheres since the revolutionary war of 1776.





The Union refused to move towards peace and reconciliation by never amending these Articles of Association and having been placed on the shelf to collect dust while the perpetual war of various actions continue.

The Treaty of Paris of 1784 did not create peace with the King of England and the Union; It created peace by and between the King of England and its company while the Union remained under these Articles of Association of October 20<sup>th</sup>, 1774 never minding its status among the family of nations with war crimes played.

The Union and Associations give rise into a new timeline, new events under new horizons, thereby changed this past with guillotine and noose long placed at rest, now to look to the futures with technologies made of old, combined with new, of concepts to the now.

Therefore, these Articles of Association are hereby amended as follows for the purpose of embracing peace and reconciliation by and between the many sides and speculators of that era of time and between the Monarchs private companies and this Union; Therefore these amends are set forth:

Repealed is the Monarch explanation of then to be preserved in prosperity, and replaced is the current time line explanation for the now. Those issues that once was in the beginning of the Declaration and Association and after the 1783 treaty, has now in time formed a despotism effect on many people of these United States. The abandonment's of those 1<sup>st</sup> created for the things of Monarch's by Washington replaced one issue with another, is currently unresolved contributing to more, whereby not so different as once was, returns back to the originating time.

Applying knowledge of this measure, serves to honor those whom came before us, as was known by this Frenchman Claude Frederick Bastiat (1801-1850), his statement of their time to France ignored, gave disclosure of socialism as a fallacy, which continues to





degenerate into some form of communism and totalitarianism despotism leading to become intolerably oppressive, lawlessness, and anarchy, then to inevitable war. This current time is that America is a divided nation and divided political status has been corrupted, and thus to preserve a nation, this perpetual Union restores what was taken in prize, taken in crimes of war, restoring that as was redefined by socialism and totalitarianism despotism and the elite communist activities such as those in Europe applied to the America's. In this era of time, the real American's are those born within The United States of America, and those whom lawfully immigrate and vet their capacity by allegiance therein. Therefore today with the Law perverted, and the powers of state perverted with it, thus is upon these governments and this new Government to correct these errors, and establish the forum for the people, not just to insure their prosperity, but to continue in freedom in their Law, vacant of economic slavery.

## Article I

### Import and Exports

As repealed and amended herein, this country known as The United States of America and its Union as amended therein, shall negotiate any and all import and export as deemed necessary or with any other country commerce unless bona fides of contract consideration that compel otherwise.

## Article II

### Slavery

As repealed and amended herein, this country known as The United States of America and its Union as amended therein, shall not support any form of any kind of slavery, and shall support the Law of Nations and/or Universal Declaration of Human rights of several version types explicit to people and children and International Lawyering protections, subject to this Governments statues or including exemptions when made on demand.





### Article III

#### Ports and Use

As repealed and amended herein, this country known as The United States of America and its Union as amended therein, the Union shall have its own ports for export and import of well-regulated trade and commerce under bona fides of consideration that compel or that not compel, with other parties subject therein.

### Article IV

#### Parliament(s) and Law

As repealed and amended herein, this country known as The United States of America and its Union as amended therein, shall not co-mingle their parliament or government offices with other countries, even when in demand by United Nations and foreign courts unless by National assembly review with proper Law and Doctrine and Laws of Nations, and shall keep vacant any such bona fides of consideration that compel otherwise.

### Article V

#### Merchant Law, Law of Sea

As repealed and amended herein, this country known as The United States of America and its Union as amended therein, all the export and all the import of well regulated trade and commerce under bona fides of consideration that compel or not compel with other parties subject therein, shall be made and negotiated under other types of contract consideration, vacant to forms of Roman curia or other economic slavery to comply with Article II, as such the National assembly shall devise for remedy any defaults.

The United States of America and its Union(s) reserve credit and is reserved made unavailable to no other country or entity or corporation or proxy.







## Article VI

### Admiralty

As repealed and amended herein, this country known as The United States of America and its Union as amended therein, all vessels registered under the Government of The United States of America and its Union shall fly the flag of The United States of America and its Union, and exempt thereof when in compliance of another Jurisdiction upon the seaways. All goods exempt or considered contraband shall be known before docking and entry into any jurisdiction, as to eliminate foreign controversy. Under acts in war, The United States of America and its Union(s) shall be under compelled restraints as deemed necessary. All Captains, or masters to receive goods under the jurisdiction of The United States of America and its Union(s), either of commodities, commerce, armament, People, and other subject matter listed by the port, shall be within the scope of the agreements made with The United States of America and its Union(s), and its port for international trade and commerce.

## Article VII

### Animals, People, Instruments of Mass Destruction or Components of Radiation

As repealed and amended herein, this country known as The United States of America and its Union as amended therein, shall restrict for international trade and commerce, of animals when known infected or animals not checked for disease without a check of veterinary competent clearance. People shall not be trafficked in any form of slavery, and any forms of devices of mass destruction by disease or nuclear or capable of mass killing of more than 100 in one occurrence constitutes such device. Magnets and other such small radiation element for useful purpose and medicine and experimental labs can provide manifest for clearance. Poisons whereby capable to mass kill by water supply in municipalities can provide manifest with useful product declaration for scrutiny and clearance.





## Article VIII

### Industry Economy and Choice

As repealed and amended herein, this country known as The United States of America and its Union as amended therein, the Union will, in those several stations or all other separate and equal stations established, shall promote or encourage economy, industry agriculture, arts and the manufactures in country to include spirits and armament for self-preservation, and will promote or encourage prosperity, competition and acknowledge the human right of choice (not associated with death over life), including horse racing, all kinds of games, plays and entertainments, all vacant of frauds and thefts, to includes that not enumerated herein, when not contrary to the Union or law thereof.

## Article IX

### Consumer

As repealed and amended herein, this country known as The United States of America and its Union as amended therein, the Union shall protect consumers from any entities, in times of flood, volcano's, hurricanes, water or food shortages, disasters or emergencies, and others not enumerated, when life is in peril or death is emanate, by freezing prices for the short term of 30 days and recurring when desired, starting when notified by The United States of America and its Union.

## Article X

### Merchants, Traders and Sovereign entities

As repealed and amended herein, this country known as The United States of America and its Union as amended therein, whereby all Business entities or person(s) or foreigners doing business in these governments or this Government are to file appropriate forms and make Commerce compliance thereto.





## Article XI

### Enforcement of Articles

As repealed and amended herein, this country known as The United States of America and its Union as amended therein, the Union and these Associates may have enemies, even unknowns, the preponderance of evidence in North-America history has shown it is these sets of Peoples when their actions set forth their intentions: Communist, Islamist, Socialist with Agendas, Leninist, Marxist and forms of anarchist, religious zealots of Political Military ideology and therefore it is the Union and the Associations whom are herein obligated to establish some form of journalism or reports or publications or warning or actions to secure thereby a remedy to secure the Union and Associations.

## Article XII

### Committee of correspondence

As repealed and amended herein, this country known as The United States of America and its Union as amended therein, the committee of correspondence, in the respective States, do frequently inspect the entries of their ledgers, and inform each other, from time to time, of the true state thereof, and of every other material circumstance that may occur relative to this association through the General Post Office of the Government of The United States of America.

## Article XIII

### Manufacturing and Monopoly

As repealed and amended herein, this country known as The United States of America and its Union as amended therein, All manufactures of this country be sold at reasonable prices, that no undue advantage be taken of a future scarcity of goods and/or to create an National assembly established definition of a monopoly.





## Article XIV

### Armament

As repealed and amended herein, this country known as The United States of America and its Union as amended therein, A Military format, standing or not, shall be configured, and set with rules, and guides to function to protect and preserve The United States of America and its Union and Association. All men and women of Military Training or not are obligated to join or assist the Military. These obligations set forth that residents or Nationals of The United States of America, are a Militia. This category authorizes men and women to be armed for such purpose. These armaments are under a parallel relationship with the united states inc, and have no enforcement under their statutory constraints such as NFA (National Firearms Act) or The Gun Control Act of 1968 (GCA or GCA68). To eliminate controversy, a devised scheme and some sort of identity or The United States of America card needs be devised, and just who, where, when and how an open carry under automatic or non-automatic arms are presented in the eye of the Public.

In addition, certain explosives or arms with projectiles of explosive carriers of explosive tips, and storage thereof absent of storage bunkers, need specific direction.

## Article XV

### Government National Property, Rights, and Etiquette

As amended new herein, this country known as The United States of America and its Union as amended therein, has established its identity and International Character as a Country with its flag shown herein and flag rights, and vessels on the sea with this Government registration shall post same upon the seaway and all water in jurisdiction contingent upon vessel criteria of National assembly definition when in private use versus uses under Commerce thereof.







Any claims as once was to all properties of that time past, excluding when holders claims made thereon, and shall be held in demand under international notice to all holders thereof, upon notice of intention to remedy. All holders shall be held on International Law and served by International Posting and/or some filing under a representation by the Ambassador of this Government or delegation of responsible appointees, even when foreign under approval of National assembly. Further, This National assembly redeems under its care custody and control, The Parks under its metes and bounds, and those progressive or Communist of the early 1900's ancient pledges or not, that have claimed lands under such agendas to possessing and the trade or selling of these lands or waterways shall be under proper title, under claims that compel lawful actions beyond the controls and acquisitions of this Government.

Sale is only under alodial title. Compromised non sales are under controversy subject to remedies therein. Compromised non sales under a controversy vacant of consideration are subject to remedies therein.

Since ownership versus what a country recommends as its official Anthem are separate things, determinations are made herein.....





## Article XVI

### CO-Governments, Cultures and America's Natives

As amended new herein, this country known as The United States of America and its Union as amended therein, have many discoverers and natives, domestic or not domestic to the Lands of America's. These with standing or not, in controversy could be applied to one or the other to practically every Native or Non-Native, where years past these issues when thought remedied, solved and monetized in settlements, mostly not to ever get a remedy. It is complicated with religions in claims of Global character, crossing into Lands of Native boundaries or Non-Native peoples, same issues in this current time-line of 2017 with Globalism and Peoples trying to control property and other Peoples.

These Peoples of America in the Jurisdiction of this Government shall be given consideration along with us all if born onto this Land else are Foreign American's subject to Immigration under Law, to have their representation heard, under the same standing as any other. To carry on into the future requires freedom, self-maintained by those free, and the ability as a group of People to perpetuate relationships respective to one another. In retrospect, do not make the People of this Government be your mother.

As these Lands of America become smaller and Peoples become larger, and the World seems to be smaller, it is not understood to be any better, a way for People to live together except to make negotiation for those things of adversarial or controversy. No Lawyer or Attorney can speak any better for you than yourself. There is no need for so called privileges of a Monarch. Those are for those whom want to be subject to anothers slavery.





## Article XVII

### Finance, Currency and Counterfeit Property

As amended new herein, this country known as The United States of America and its Union as amended therein, has currently restored and adopted its legal tender as The Continental Dollar. When backed by Gold and Silver, it shall mean only to be replaced by a form as a substitute replacement because a controversy has, if such where to be unsettled, caused a harm under this Government's currency, and placed all into a harmful maxim, because it was used in good faith. The National assembly shall make this in Law and definition if and when such where placed to affect currency backing.

These currency's establish a usable property of The United States of America and its Union. The Law under this National assembly, to repel those whom copy, change denomination, or counterfeit this Government's currencies, this enforcement is not exclusive of any named type. The National assembly shall set forth such remedy of those foreign or domestic, by punishment in jail or other pain in a penalty as needed to protect assets of The United States of America and its Union, by theft or by espionage or by spies engaging in a silent war or by subversive activities under groups with harmful intent.

The departments of Finance and others under responsibilities for currency management with the National assembly shall set forth such decisions with this National assembly as to Currency in use versus Currency available for use, on National sense and a Means method to determine what foreign use has removed what amounts from domestic flow.





The National assembly shall devise Financial Bonds and other Instruments not deemed nefarious, but useful without frauds or crimes, to provide The United States of America

and its Union a funding mechanism that provides currency source to resourceful matters or under pledges or grants for Commerce or Business promotion. The National assembly shall define its particular method and forum for this subject-matter.

## Article XVIII

### Human Rights, Defenders, and Police

As amended new herein, this country known as The United States of America and its Union as amended therein, shall develop a Law enforcing Power, specific to the jurisdictions charter and/or in other matters specific to the domestic charter of the court, and those violations in scope will need be heard and adjudicated under this Government court(s) when human rights are in violation. The parallel with the United States Inc, gives rise to future situations where this Government may obtain its people, and may need enforcement due to terrorism or civil structure for quasi Military controversies.

The author herein has provided many years of Common Law with its history and important lawful ideologies for these courts and those customary methods and use of a Long history by William "Bill" Thornton, as a Common Law Master practiced in courts under the State of California, with much thanks to his personal efforts, and here that is commended. This is to initiate a process to establish these concepts, whereby Human Rights Tribunals can not handle all those things needed by a court.







## Article XIX

### Military

As amended new herein, this country known as The United States of America and its Union as amended therein, and This National assembly has restored and defined its Military, The Continental Army, its Continental Marines, and Continental Navy, and re-established its ranking, and Commissioned and Non-Commission protocol, either as a standing Military and of Pay or as a Militia reserve like status, and by acceptance under oath, incentives to Nationalization can be offered. Administration and Advisements can be instituted by the National assembly, with Law enforced as to desertion, espionage, and subversion, as developed by the National assembly, Joint Chiefs of Staff, and department heads. The standards and rankings will follow the protocols as needed and adopted by the Continental Army.

## Article XX

This association shall claim its rights under the Declaration of Rights published on May 7th, 2014 and attached hereto.

### Reservation of Rights

As repealed and amended herein, this country known as The United States of America and its Union as amended therein, is herein amended, and we do solemnly bind ourselves and our constituents, under the ties aforesaid, to adhere to this association, and hereby reserve the right to amend, add thereto, repeal and restructure these articles of which guide the Union also known as the States of the Union to prosperity, peace and reconciliation within the family of nations.
