BE IT RESOLVED, that a motion was carried by the National assembly to file the New Hampshire House Bill 1778 statute to be reviewed for human rights compliance accuracy by the General Post Master Council for the Government of The United States of America; and

FURTHER BE IT RESOLVED, the office of the Governor will stand in front of the General Post Master Council for the Government of The United States of America, on behalf of the National assembly to adjudicate the accuracy of the New Hampshire House Bill 1778 statute; and

BE IT RESOLVED, that a motion was carried by the National assembly to authorize the Trustee of the CONCEALED WEAPONS PERMIT to transact business across State lines; and

BE IT RESOLVED, that a motion was carried by the National assembly for the office of the Governor for the Government of The United States of America, to serve as the Joint Chiefs of Staff in the Continental Army for the Government of The United States of America; and

BE IT RESOLVED, that there were no objections that the foreclosure proceedings commence against the United States for back taxes; and

FURTHER BE IT RESOLVED, the [Private Attorney Generals Across America are the agents on the aforementioned proceedings;](#)



BE IT RESOLVED, that a motion was carried by the National assembly that the Human Rights Tribunal International convene as the War Crimes Tribunal; and
