Judgment and Order. Writ of Execution

WHEREAS, the General Post Master Council has determined that the evidence presented shows beyond a reasonable doubt that the Respondents(as Inhabitants) are guilty of the following crimes including but not limited to theft of property, rebellion and insurrection, trespass, sedition, advocating overthrow of government, forced association, theft of time and energy, domestic warfare, attempted trafficking of persons, attempted slavery of an entire population, treason against the Government of The United States of America, and attempted usurpation of the American National Union of The United States of America, and

WHEREAS, Respondents committed theft of property by plagiarizing the Bilateral Social Compact by and between the people for The United States of America thereby attempting to usurp the authority of the people in order to feign bilateral support for the crimes committed therein against the signatories. Respondents are hereby charged violating the 5th and 7th Law of Noah as given by our Creator: Do Not Steal. Do not bear false witness. The respondents amended the Bilateral Social Compact and presented it as if the amendments were unanimous.

Further the theft of this intellectual property from the people for The United States of America violates Public Law 101-17-1 and 101-17-2 wherein it states (1) Everyone has the right to own property alone as well as in association with others. (2) No one shall be arbitrarily deprived of his property.

WHEREAS, excerpted from “*The Law of Nations: Or Principles of the Law of Nature, Applied to the Conduct and Affairs of Nations and Sovereigns*”, written by Emer de Vattel.

CHAPTER XIX: Of our Native Country, and several Things that relate to it.

§213. Inhabitants

“The inhabitants, as distinguished from citizens, are foreigners, who are permitted to settle and stay in the country. Bound to the society by their residence, they are subject to the laws of the state, while they reside in it; and they are obliged to defend it, because it grants them protection, though they do not participate in all the rights of citizens. They enjoy only the advantages which the law or custom gives them. The perpetual inhabitants are those who have received the right of perpetual residence. These are a kind of citizens of an inferior order, and are united to the society, without participating in all its advantages. Their children follow the condition of their fathers; and as the state has given to these the right of perpetual residence, their right passes to their posterity.”

WHEREAS, Respondents: Sean Will Gary Beller, Neal Harrison Cornett, Elizabeth Ann Cornett/Whitson, and Steven Preston Barker have proven to be an attacking force through repeated treacherous and malicious actions toward the Claimant, as well as the country and its people, and through Respondents’ own deeds and actions have shown that Respondents’ are inhabitants incapable of self-governance.

WHEREAS, the General Post Master Council for the Government of The United States of America has assessed value of this case in the total amount of Four Hundred Thousand CD, (+400,000) or equivalent, to be paid in assets of value, payable in Legal Tender, land or cured trust property under the classification of a fine allocated towards damages caused by these crimes.

JUDGMENT

NOW THEREFORE:

BE IT JUDGED, that the Great Jury True Bill of Indictment brought to the General Post Master Council is evidence of violations of all Public Laws-101. The evidence proves that the Respondents did steal foundational information and bear false witness to instigate the theft of an entire country. Respondent’s continual trespass is rebellion and sedition. Respondents are inhabitants advocating the overthrow of the Government of The United States of America. Through ongoing forced association, theft of time and energy, domestic warfare, trafficking in persons, gang stalking through electronic frontiers, and attempted slavery of an entire population. The Respondents stand guilty by the evidence presented and are in default through nonresponse to this Court.

ORDERS

BE IT ORDERED, that the Respondents are banished/exiled, and all administrative records be removed from the Government of The United States of America, are sentenced to permanent exile outside the metes and bounds and seaward boundaries of The United States of America, and a fine of +400,000 CD for Respondents treacherous crimes, especially the attempted theft of power of attorney to enslave an entire population in violation all 30 of the Public Laws-101, and

FURTHER BE IT ORDERED, that all sovereignty, nationality, freedoms, liberties, rights, privileges, immunities, reputation and international character of the Claimant are in good standing. Peace is hereby upheld to the Claimant because the un-rebutted claim of existence for The United States of America stands as evidence in fact to the Countries rightful place among the Nations, and

FURTHER BE IT ORDERED, that any further evidence of violations of the Public Laws-101 or any other deprivation of character will be sent to the Law Department of the American National Union for The United States of America for further review for possible further charges under Public Law and or international law, and

FURTHER BE IT ORDERED, that no retaliation or harassment against the Government of The United States of America, its office holders, or any other American National shall be tolerated, any and all retaliation by any and all shall be resisted with automatic arrest of the Public Law violator and tried in this General Post Master Council immediately upon a proper affidavit and evidence to support the violation, and



FURTHER BE IT ORDERED, that any articles on the internet or elsewhere that attempt to distort the history of The United States of America, the Government of The United States of America, and the American Nationals thereof, is an attempt to interfere with the Social Compact Agreement of its people, or attempt to cloud its chain of title is an act of terrorism against The United States of America and in violation of the Public Laws-101, and

FURTHER BE IT ORDERED, that the Law Department of the American National Union for The United States of America reserves the right to utilize this Judgment and Order and any and all evidence herewith in any future charges or court actions in this or other court of Law.

FURTHER BE IT ORDERED, that an assessment for damages be sent to the office of the Treasury for The United States of America, Global Postal Code: NAC: 850H2 MR7C8-0007, The United States of America For the purpose of attaching a fine for the monetary damages associated with Violations of all 30 Public Laws-101 of The United States of America

GENERAL ORDER

FURTHER BE IT ORDERED UNDER GENERAL ORDER: that any and all Foreign Monarchs, Governments, incorporated and/or unincorporated Associations, Agencies or agents thereof are hereby ordered to cease and desist any and all interference or disruptive actions towards The United States of America, the Government of The United States of America, American Nationals, the Social Compact Agreement of its Nationals, the power of attorney, its Law form, and freedoms thereto, and

Therefore, by the authority vested in the General Post Master Council by the National assembly of the Government of The United States of America, the following is hereby declared:

That, this judgment and order is hereby executed upon the default of respondents, and that the evidence presented reaches beyond a reasonable doubt. All damages are immediately due and payable to the Treasury for The United States of America. And,
That, if after 90 days, these damages remain unpaid, this judgment shall stand as a lien until satisfied.
