On this 144<sup>th</sup> day in the year of Yahweh, six thousand and twenty three, and the 10<sup>th</sup> day of August two thousand and twenty first year of the new covenant in Yahushua's name, at 12:40 Universal Time -6, the American Nationals for the Government of The United States of America, and all other interested persons convened a meeting for the assembly, identified as **Telegram – General Post Office**.

### Official Assembly Record

**BE IT RESOLVED**, that a motion to classify the following organizations, associations and entities as Satanic organizations including but not limited to the American Medical Association (AMA), Association of Independent Doctors, International Medical Association, International Medical and Disaster Association, World Health Organization, (WHO) and Centers for Disease Control and Prevention (CDC), who employ baphomet worshipping satanic priests to conduct psychological operations through main stream media to incite discrimination against unvaccinated inhabitants and their posterity thereby warring with families to make them conform to accepting the mark of the beast and the antichrist system; and

**FURTHER BE IT RESOLVED**, the following organizations, associations and entities as Satanic organizations including but not limited to the American Medical Association (AMA), Association of Independent Doctors, International Medical Association, World Health Organization, (WHO) and Centers for Disease Control and Prevention (CDC) logo/seals are as follows:

**FURTHER BE IT RESOLVED**, Wherein it states in Matthew - 10:26;

*"So have no fear of them, for nothing is covered that will not be revealed, or hidden that will not be known"; and*

**FURTHER BE IT RESOLVED**, that evidence provided herein of the U.S. Congress' intent to offer special protections to the Baal Peor Religious Community through H.R.5 - Equality Act in favor of rights over others; and

**FURTHER BE IT RESOLVED**, that the Equality Act passed by the House of Representatives on May 17<sup>th</sup> 2019 conveys a clear intent to offer special protections to the Baal Peor religious community (LGBTQ+ community) including but not limited to allowing access to shared facilities including a restroom, a locker room, and a dressing room, that is in accordance with the individual's gender identity, which elevates their rights over the rights of others violating basic human rights through forced association of biological males and females having to share the aforementioned facilities with their self identifying nonbiological counterparts; and

**FURTHER BE IT RESOLVED**, by expanding the definition of "public accommodations" to include "places or establishments that provide (1) exhibitions, recreation, exercise, amusement, gatherings, or displays; (2) goods, services, or programs; and (3) transportation services."; the said act could be used by inhabitants to declare any hospital or establishment providing medical services as a "public accommodation" to force medical professionals to provide sex change surgeries and gender transition hormones against their will as the bill further "prohibits the Religious Freedom Restoration Act of 1993 from providing a claim, defense, or basis for challenging such protections." <https://www.congress.gov/bill/116th-congress/house-bill/5>; and

**FURTHER BE IT RESOLVED**, the purpose of the classification is to publicly identify these associations as organized satanic religious organizations bearing false witness to the inhabitants about a global pandemic in collusion with the U.S. Congress and to declare these psychological operations as a violation of the established public religion of the permanent population for The United States of America established on 9/1/2020 <https://departmentoftransportation.theunitedstatesofamerica.country/bilateral-social-compact/>; and
