**BE IT ENACTED**, by the United States, in Congress assembled, FORCED DEPORTATION ACT OF 2021, IS HEREBY ESTABLISHED, PUBLISHED AND ACKNOWLEDGED on this 150<sup>th</sup> day in the year of Yahweh, six thousand and twenty three, and the 16<sup>th</sup> day of August two thousand and twenty first year of the new covenant in Yahushua's name.

## REGULATIONS-PENALTIES OF THE ACT



- 2. Anyone found not voluntarily removing their person, possessions; family etc. shall suffer a greater punishment by the following but not limited to methods of enforcement until deportation shall have been fulfilled, and
  - a) Immediate Nationalization of all private property.
  - b) Automatic lien against all monetary property.
  - c) Demolition of all private homes until all destroyed wherein there is nowhere left to seek aid and comfort.
  - d) Death of anyone is strictly forbidden during the enforcement of this act.
