# FORCED DEPORTATION ACT OF 2021

08-10-2021



By the authority of the faith of the assembly of American Nationals, in Union under the Law of Nations, and all Acts, petitioned, accepted and acknowledged by the current United States, in Congress assembled, are hereby ordained for the safety and security of our posterity, enact the following:

### SUBJECT MATTER OF THE ACT



The Subject Matter of the FORCED DEPORTATION ACT OF 2021 is to enforce a deportation order against a person who is declared an enemy of the country by way of pushing the New World Order agenda to be determined by the National assembly for the Government of The United States of America.

## SUBJECT MATTER OF THE ENACTMENT

1. Maintain humanity under 500,000,000 in perpetual balance with nature.
2. Guide reproduction wisely — improving fitness and diversity.
3. Unite humanity with a living new language.
4. Rule passion — faith — tradition — and all things with tempered reason.
5. Protect people and nations with fair laws and just courts.
6. Let all nations rule internally resolving external disputes in a world court.
7. Avoid petty laws and useless officials.
8. Balance personal rights with social duties.
9. Prize truth — beauty — love — seeking harmony with the infinite.
10. Be not a cancer on the earth — Leave room for nature — Leave room for nature., and

**BE IT ENACTED**, by the United States, in Congress assembled, FORCED DEPORTATION ACT OF 2021, IS HEREBY ESTABLISHED, PUBLISHED AND ACKNOWLEDGED on this 150<sup>th</sup> day in the year of Yahweh, six thousand and twenty three, and the 16<sup>th</sup> day of August two thousand and twenty first year of the new covenant in Yahushua's name.

## REGULATIONS-PENALTIES OF THE ACT

1. Anyone found attempting to enforce the aforementioned social compact within the metes and bounds and seaward boundaries of The United States of America shall be deported immediately, and
2. Anyone found not voluntarily removing their person, possessions; family etc. shall suffer a greater punishment by the following but not limited to methods of enforcement until deportation shall have been fulfilled, and
  - a) Immediate Nationalization of all private property.
  - b) Automatic lien against all monetary property.
  - c) Demolition of all private homes until all destroyed wherein there is nowhere left to seek aid and comfort.
  - d) Death of anyone is strictly forbidden during the enforcement of this act.
