On the 24th day of February in the year 2014, at 7:00 PM Central, The Citizens, Nationals and Residents of The United States of America, and all other interested persons hereby convenes.

Minutes and Resolutions

BE IT RESOLVED that, the General Post Master Council hereby nominates Gregory Todd Johnstone for Clerk of the Court alternate.

FURTHER, BE IT RESOLVED that, the Assembly had no objection to the nomination of Gregory Todd Johnstone for Clerk of the Court alternate.

BE IT RESOLVED that, the assembly of affirmed American Nationals made the decision; regarding Tom Murphy - NSEA International, to suspend the Tort Claim due to the prior tortious interference already committed by Tom Murphy against another trust, witnessed by others. Foreign internal actions have already been taken to resolve the problem and promises have been issued to implement a prosecution of the criminal activities by Tom Murphy and associates.

FURTHER BE IT RESOLVED, that if no prosecution has been implemented within 6 months against Tom Murphy for multiple crimes within his own documents, signed with Notary stamp, the assembly will lift the suspension of the tort claim and implement its own prosecution against Tom Murphy for the crimes confessed by Tom Murphy and witnessed by the assembly.

FURTHER BE IT RESOLVED, that Tom Murphy's latest accusations against the office of the Governor amounts to attempting to prosecute a general post master for delivering a message. Further, the accusations by Tom Murphy fail to serve as a diversion from the liabilities of the tort claim and Notice from the assembly.

FURTHER BE IT RESOLVED, that all accusations by Tom Murphy are without merit and fail to focus on the tort claim itself wherein a simple changing a capital "N" to a lower case "n" on an id card would of resolved the whole matter.

FURTHER BE IT RESOLVED, that due to the extremely violent and infantile response to the Notice, it is clear that Tom Murphy is not qualified to engage in International Relations and seriously lacks comprehension skills. Further, Tom Murphy displays the inability to react in an adult manner to situations Tom Murphy perceives as a threat to his ego and position. Therefore, Tom Murphy cannot decipher the difference between himself and his ego. Tom Murphy believes his ego is Tom Murphy, and not a part of Tom Murphy.

BE IT RESOLVED, that Tom Murphy will not be offered any type of status with this Government anytime soon.

BE IT RESOLVED that, the meeting for the Assembly adjourned on the **24th** day of **February, 2014**, to re-convene at a future date certain.
