On the 23rd day of June in the year 2014, at 7:00 PM Central, The Nationals and Residents for The United States of America, and all other interested persons convened a meeting for the Assembly, identified as MMIN-20140623-ASMBLY.

Minutes of the Meeting

BE IT RESOLVED, that the MOTION and ORDER: The Law of Nations shall be recognized, accepted and acknowledged by the Supreme Court of the Confederacy of The United States of America as delivered by order of the General Post Master Tribunal upon motion of the Post Master General of The United record, and

FURTHER BE IT RESOLVED, that The Supreme Court of the Confederacy of The United States of America hereby accepts and acknowledges delivery of the enforcement authority of the Law of Nations, the governing authority for the States of the Union also known as these United States, and

FURTHER BE IT RESOLVED, that The United States, in Congress assembled hereby accepts and acknowledges the MOTION and ORDER, and shall support the decision of the Tribunal without any reservations, and

FURTHER BE IT RESOLVED, that the MOTION and ORDER will be sent to the Pentagon and the Vicar General.

BE IT RESOLVED, that a motion was carried whereas The Committee for the Government of The United States of America will organize these United States International Law Association and shall be formed and readily available for people to be law certified in different fields of law.

BE IT RESOLVED, that a motion was carried by the Affirmed American Nationals to amend the wording for the Acknowledgement for the Office for International Notary for the reign of the heavens, and the Government for The United States of America, and **FURTHER BE IT RESOLVED,** that the original wording on the Acknowledgement originally read:

On Month Day, 20___ before me, _____, International Notary in Common Law, personally appeared ______ a credible living, self-aware sentient man, who proved to me on the basis of satisfactory evidence to be the man whose name is subscribed to the within instrument and acknowledged to me that he executed the same in his authorized capacity, and that by his signature on the instrument, he/she, executed the instrument.

I certify under penalty of bearing false witness under the laws of the Confederacy for The United States of America that the foregoing paragraph is true and correct, and

FURTHER BE IT RESOLVED, that the amended International Notary Acknowledgement is amended as follows:

On Month Day , 20__, I, _____, International Notary under the Law of Nations, personally appeared before me, one _____, whom proved to the office on the basis of satisfactory evidence to be the man whose name is subscribed to the within instrument and acknowledged to the Notary office that ______ executed the same in ______ authorized capacity, and that by ______ signature on the instrument, ______ executed the instrument.
