The trustees of the Temple of 𐤆𐤃𐤓𐤕, (hereinafter, the “**Temple**”) hereby convenes to discuss the procedure for the sovereign community to properly accept and acknowledge the Grantor/ Beneficiary of the universe; and

BE IT RESOLVED, that “*The New Yerushalayim World Trust*” Seal has been amended to “*the great seal of the reign of the heavens*”:

FURTHER BE IT RESOLVED, that the following Seal for the reign of the heavens Society Temple has hereby been adopted by the trustees of the Temple of རྒྱལ་ཁབ་:



FURTHER BE IT RESOLVED, that the General Post Office Government Agency under the General Post Office Articles, as amended on the 6th of April, 2016 recognized by International Trademark Association shall be the administrator for General Post Office, LDC; and

FURTHER BE IT RESOLVED, that the General Post Exchange “GPEX” shall be a member of the General Post Office, LDC membership; and

FURTHER BE IT RESOLVED, that the General Post Office, LDC shall issue its own personal identification for its official office holders; and

WHEREAS, the people in and of the world are being transferred at birth to a church on paper without their knowledge or the knowledge of the mother or father; and

Brief Explanation

After the explosion that occurs when the sperm meets the egg to form a fetus, the soul has transferred from the Grantor/beneficiary to its destination within the mother’s womb. FURTHER, BE IT RESOLVED, the acceptance and acknowledgement of the reign national status corrects the chain of title to the inheritance of the reign of the heavens that belongs to each and every human being on the planet earth and therefore and consequently resets all accounts, fiat currency and claims and all property claims that created the private church script in the first place and therefore a global reset can occur for each individual that accepts and acknowledges the reign national status; and

FURTHER, BE IT RESOLVED, that the Temple of 𐤃𐤓𐤕𐤕 hereby accepts and acknowledges the original prophet of the reign of the heavens named “Yeshayahu”(Isiah) for the correction of the record of the Temple of 𐤃𐤓𐤕𐤕; and

FURTHER, BE IT RESOLVED, that all office holders elected by the assembly of trustees within the reign of the heavens society Temple shall also fulfill the obligations as trustees of the Temple of 𐤃𐤓𐤕𐤕; and

The obligations of said offices of trust shall be succeeded by each elected officer after each election every two years in accordance to the Constitution and by-laws of the reign of the heavens society Temple as amended July 9th, 2014; and

FURTHER, BE IT RESOLVED, that the Temple of 𐤃𐤓𐤕𐤕, shall be read in the Hebrew language as the Temple of 𐤕𐤓𐤕𐤕, thereby redefining the International NAME as translated to the *paleo Hebrew* language of the reign of the heavens rather than *Latin*; and

FURTHER BE IT RESOLVED, that all reign nationals shall receive a Social Assistance Number (SAN) to access the underwriter privileges to buy, sell and trade in accordance with the Adam and Eve Trust and various other obligations which are defined as the current nationality of the trustee wherein the use of the SAN of the reign

national shall extend to the current obligation to ones country for the purpose of aligning the chain of title of the second nationality; and

FURTHER BE IT RESOLVED, the SAN shall be designated as X-XXXX-XXXX-XXX wherein the last 3 digits shall serve as a PIN number for security purposes. The SAN is not for the purposes of identification insofar as the individual is concerned. The SAN is for the purpose of accounting the buy, sell and trade record of the trustee that has accepted and acknowledged the original Grantor/beneficiary; and

FURTHER BE IT RESOLVED, the Temple of 𐌹𐌿𐌹𐌿; and shall serve as administrator of records for the SAN for reign nationals; fund transfers and accounting shall be governed by the General Post Office Government Agency in GPEX; The General Post Master Council shall govern Peaceful settlement of disputes; the Continental Public Bank shall be the servicer for the account servicing promissory notes and underwriting; The Office of Deeds and Recordings shall be administrator of records for all assets of the Treasury that is governed by the office of the Treasury for the Government of The United States of America and reported by the office of the Governor for the Government of The United States of America to the National assembly; and

Process for obtaining a reign national status:

1. Contact the reign of the heavens society Temple: ministryofgovernance@reignoftheheavens.org
2. The email needs to contain the following information:
 - a) *Name; and*
 - b) *Email; and*
 - c) *Phone number; and*
 - d) *Request consultation to accept reign national status; and*

FURTHER BE IT RESOLVED, that a letter of acceptance and acknowledgment as a reign national, trustee, shall be autographed with the following wording:

“I _____, hereby accept and acknowledge the position of trustee of the family estate of which I am a part of its chain of title; and shall serve as trustee with honor, dignity, empathy, and respect for the covenant of the Adam and Eve Trust, and

I, _____ further accept and acknowledge the existence of the original Grantor/beneficiary that delivered my soul to its body wherein my resonance formed my character and all that I am and can achieve for my fellow human beings”; and

FURTHER BE IT RESOLVED, that the trustee shall receive a SAN card, Nationality Certificate, trustee certificate, grant deed from the reign of the heavens survey, reign national identification; and

FURTHER BE IT RESOLVED, that the trustee understands that any acceptance and acknowledgement does not remove or replace the current status of the individual, reign national status is issued under dual nationality, however, full reign Nationality can be obtained under a separate process as required by the set-apart spirit doctrine; and

Office Holders: Office holders are defined as appointed or elected within the Government of The United States of America or the reign of the heavens society Temple including but not limited to office holders within independent holding trusts of the Temple of 2313 that are elected or appointed; and
