GENERAL ORDERS OF THE TRUSTEES AS IT PERTAINS TO SWEDEN

IT IS HEREBY ORDERED, that the people of SWEDEN shall be liberated from the tyranny imposed by the Vicar of Christ of the secular trust mimicking the reign of the heavens world trust (hereinafter "World Trust") wherein the assignment of liability of the war crimes committed against SWEDEN shall be the Vicar of Christ, and

GENERAL ORDERS OF THE TRUSTEES AS IT PERTAINS TO ENGLAND

IT IS HEREBY ORDERED, that the Military of ENGLAND AND GREAT BRITAIN shall be deployed to remove the Islamic Militants from within the metes and bounds of ENGLAND and GREAT BRITAIN, and the Vicar of Christ is hereby barred from interference with the internal affairs of ENGLAND and GREAT BRITAIN, and

FURTHER IT IS HEREBY ORDERED, that the people of ENGLAND AND GREAT BRITAIN shall be known as trustees of the World Trust wherein the firing of those trustees was not warranted and wholly unauthorized, and

SO ORDERED, by The Executive Board of the General Post Office of the Government of The United States of America on the 52nd day in the year of Yahweh, 6020, and
