A parcel of land in the SE ¼ of NW ¼, Section 19, Township 9 North, Range 11 West, in the City of Laurel, Second Judicial District of Jones County, Mississippi lying south of Block A, College Heights Subdivision and North of South Yale Avenue (running E. and W.) and West of Yale Avenue (running N. and S.), more particularly described as follows, to-wit:

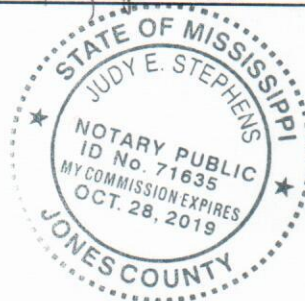
