In the matter of **Claimant: American National Union of The United States of America vs Respondent: The San Francisco Gay Men's Choir & LGBTQ+ Equality Caucus (Baal Peor Religious Community)**

JUDGMENT

Comes now, a Judgment and Order from the **War Crimes Tribunal for The United States of America**.

WHEREAS, The Tribunal examined all evidence and deliberated the elements of the case brought by the Claimant with fairness and non-arbitrary sentencing. The War Crimes Tribunal for The United States of America ensuring that the most severe crimes of concern to The United States of America and the International community do not go unpunished and are not in conflict with the Law of Nations, and

WHEREAS, The Respondents have failed to address the claims set forth by the Claimant in any form of response set forth within published International True Bill of Indictment. Pertaining to the subject matter of the case, this Tribunal finds the Respondents in default, and therefore in omission to the presentments of the Claimant, and

WHEREAS, the Claimant has claimed within evidence submitted to this Tribunal by way of a prosecution of facts presented through a published International True Bill of Indictment, [LINK](#) the Respondents having claimed power of attorney for the entire Baal Peor religious community within the Respondents' war declaration and publicly confessing to the war tactic of attacking children of their enemy directly under the laws of war with the strategy of slowly converting those children into the Respondents' satanic worship of the Baal Peor religion are found guilty of war crimes in violation of all Public Laws-101, and

INTERNATIONAL TRANSLATION

WHEREAS, the duty to honor God by the establishment of a public religion is a legal obligation of all Nations, and is necessarily under the political authority established by the written and published social compact agreement by and between the people for The United States of America [LINK](#), the Respondents have committed capital crimes against families that comprise the body politic of The United States of America by violating the National religion codified in International Law in accordance with the *Law of Nations Book 1 Chapter 12 Of Piety and Religion §129. Public establishment of religion*, and *Law of Nations Book 1 Chapter 12 Of Piety and Religion §131. When there is an established religion*, and

WHEREAS, the authority to establish a public religion established by the political authority from the covenant community as first among equals within the state of nature is codified in International law through the Law of Nations as cited below, and

Excerpt from the Law of Nations Book 1 Chapter 12 Of Piety and Religion §129. Public establishment of religion

“The establishment of religion by law, and its public exercise, are matters of state, and are necessarily under the jurisdiction of the political authority. If all men are bound to serve God, the entire nation, in her national capacity, is doubtless obliged to serve and honour him (Prelim. §5). And as this important duty is to be discharged by the nation in whatever manner she judges best,—to the nation it belongs to determine what religion she will follow, and what public worship she thinks proper to establish.” [LINK](#)

WHEREAS, the authority to protect and support the religion established by the political authority from the covenant community as first among equals within the state of nature is codified in International Law through the Law of Nations as cited below, and

Excerpt from the Law of Nations Book 1 Chapter 12 Of Piety and Religion §131. When there is an established religion.

“When the choice of a religion is already made, and there is one established by law, the nation ought to protect and support that religion, and preserve it as an establishment of the greatest importance,— without, however, blindly rejecting the changes that may be proposed to render it more pure and useful: for we ought, in all things, to aim at perfection (§21). But as all innovations, in this case, are full of danger, and can seldom be produced without disturbances, they ought not to be attempted upon slight grounds, without necessity, or very important reasons. It solely belongs to the society, the state, the entire nation, to determine the necessity or propriety of those changes; and no private individual has a right to attempt them by his own authority, nor consequently to preach to the people a new doctrine. Let him offer his sentiments to the conductors of the nation, and submit to the orders he receives from them.”

WHEREAS, the declaration of war on innocent children by the Respondents from the San Francisco Gay Men's Choir that was not disavowed by the Respondents from the LGBTQ+ Equality Caucus are liable for the aforementioned war declaration and public confession to the war tactic of converting the children of their enemy under the laws of war into direct disobedience with the Creator through the Baal Peor religion committing capital crimes against the Nation in violation of Article 3 of the Bilateral Social Compact Agreement by and between the people for The United States of America and a violation of the Law of Nations Chapter 12 §129 and §131, and

WHEREAS, It states, in Luke 17: “ it would be better for them to be thrown into the sea with a millstone tied around their neck than to cause one of these little one to stumble.” , and

WHEREAS, It states, in Deuteronomy 4:3 “ you saw with your own eyes what the Lord did at Baal Peor. The Lord you God destroyed from among you everyone who followed the Baal Peor”, and

JUDGMENT

NOW, THEREFORE, the Tribunal hereby renders the following judgement pursuant to all the facts presented by the Claimant upon the Respondents and finds the Respondents guilty in all matters presented, and

BE IT JUDGED, that the claims brought forward to the War Crimes Tribunal gives witness to the existence of capital crimes against families and violations of all thirty articles of the Universal Declaration of Human Rights known as Public Law-101. The Tribunal finds the evidence proves the Respondents are engaged in ideological subversion of the inhabitants within the country and have hijacked the term 'Gay' to disguise their Satanic religion in order to destroy the family structure by conducting malicious marketing campaigns fomenting an agenda that violates basic human rights through forced association, while claiming religious rights to worship Satan. The Respondents of the US Congress have been complicit in offering special protections to the Baal Peor religious community [LINK](#) over the rights of others which is akin to the establishment of a religion, and is a violation of the public religion established by the people for The United States of America. ORDERS

BE IT ORDERED the San Francisco Gay Men's Choir and the members of the LGBTQ+ Equality Caucus representing the entire Baal Peor religious community are now classified in perpetuity as terrorist organizations that are harboring war criminals.

BE IT ORDERED any Respondents involved directly or indirectly with child trafficking within the metes and bounds and seaward boundaries of The United States of America will be immediately executed, death by hanging.

BE IT ORDERED, the Rainbow Flag of homosexuality shall be outlawed as a war flag, and any place of display shall have a One Million Dollar (+1,000,000) lien applied to each and every circumstance upon the Respondents and their supporters, when seen in Public view, if there is one or more each shall be counted as one and totaled in amount, and

BE IT ORDERED, the Respondents shall have a One Million Dollar (+1,000,000) lien placed upon each conspirator's person named within the forthcoming Notice of Exile along with any supporters and co-conspirators, and

BE IT ORDERED, no instructor in any capacity that is or has been affiliated with Respondents may be near any child/children in part or in whole, such an event will result in the publication of another One Million Dollar (+1,000,000) lien against the offender's person, and

BE IT ORDERED, all Respondents are barred from all Public Places, if found it is a One Million Dollar (+1,000,000) lien upon each person, being one receiving and the other accepting patronage, and

BE IT ORDERED the nine openly LGBTQ+ members of the United States House of Representatives in the 117th Congress who serve as Co-Chairs of the Congressional LGBTQ+ Equality Caucus are hereby immediately exiled and deported from the metes and bounds and seaward boundaries of The United States of America, in accordance with the FORCED DEPORTATION ACT OF 2021, [LINK](#)

BE IT ORDERED, the LGBTQ+ members of the United States House of Representatives who serve as Co-Chairs of the Congressional LGBTQ+ Equality Caucus listed below will receive the death penalty and face a firing squad if they return to The United States of America, and
