NATIONAL ID STATUTE

By the authority of the faith of the assembly of American Nationals, in Union under the Law of Nations, and all Acts, petitioned, accepted and acknowledged by the current United States, in Congress assembled, are hereby ordained for the safety and security of our posterity, enact the following on the 14th day of September 2015,

True Nationals of countries do not need permission of movement in their own country.

Universal Declaration of Human Rights Article #13

- (1) Everyone has the right to freedom of movement and residence within the borders of each State; and
- (2) Everyone has the right to leave any country, including his own, and to return to his country.

Law of Nations

"Swiss lawyer Emmerich de Vattel (1714–67) agreed that people 'may quit a society which seems to have dissolved itself in order to unite again under another form; they have the right to retire elsewhere, to sell their lands, and take with them all their effects'.59 In the Law of Nations, he concluded that 'a person may quit his country' because every man is born free; and the son of a citizen, when come to the years of discretion, may examine whether it be convenient for him to join the society for which he was destined by his birth. If he does not find it advantageous to remain in it, he is at liberty to quit it on making it a compensation for what it has done in his favour, and preserving, as far as his new engagements will allow him, the sentiments of love and gratitude he owes it." https://www.law.unimelb.edu.au/files/dmfile/download63181.pdf

REGULATIONS OF THE STATUTE ENACTED

The National Identification Card shall be issued for the purpose of showing Nationality within The United States of America with the following information attached thereto: Issuing: Department of State for The United States of America with Universal Jurisdiction:

The card also contains the following items:
Emblem of The United States of America;
Unique identification number of the card with 12 digit number series Photo of cardholder;

The identification process is restricted to information that passes the test of responsible party doctrine meaning that that the information provided does have sufficient information to identify someone that may be involved in a crime or other breach of the peace, however, does not violate;

Article 12 of the Universal Declaration of Human Rights No one shall be subjected to arbitrary interference with his privacy, family, home or correspondence, nor to attacks upon his honour and reputation. Everyone has the right to the protection of the law against such interference or attacks, and upholds:



Article 6 of the Universal Declaration of Human Rights Everyone has the right to recognition everywhere as a person before the law, and

Article 15 of the Universal Declaration of Human Rights

- (1) Everyone has the right to a nationality.
- (2) No one shall be arbitrarily deprived of his nationality nor denied the right to change his nationality.

The General Post Master Council for The United States of America and the Government of The United States of America is with the exclusive right to recognize a Nationality claim and sealed with an oath or affirmation granted by the National assembly, and Further, the Government of The United States of America is with the exclusive right to keep a record of the information provided by the information provider for the purposes of settling a dispute by properly identifying the responsible party. The information provided is required to be without violating the responsible parties privacy with information not relevant to the claim against the responsible party in any court of the Government of The United States of America.
