FURTHER BE IT RESOLVED that, all Human Rights Tribunal cases on record for American Nationals will be reviewed and Proclamations and statutes will be written accordingly, and

FURTHER BE IT RESOLVED that, a journal of the day to day proceedings will be kept on the National Great Registry and will be called Congressional Journal, and
