## **MISSION STATEMENT FOR The USC Chamber of Commerce**

The United States, in Congress assembled strives to legislate the balance through neutrality of the war by and between the land and the sea, thereby creating peace and ending a perpetual conflict.

The United States, in Congress assembled hereby designates the NGO called "The USC Chamber of Commerce" as a neutral, non-combatant forum for combating parties to convene and resolve their disputes. The Peace Treaty formed through those meetings shall serve the human race in a manner that has not been witnessed in many centuries.

#### History:

The USC Chamber of Commerce was originally created by the reign of the heavens society Temple. Its purpose and creation was donated to the Government of The United States of America to facilitate agreements with other chambers of the same character for trade and commerce on land and the sea.

The USC Chamber of Commerce has witnessed the atrocities of one party, attempting to monopolize the sea ports and public property, and the other party attempting to monopolize all trade and commerce on land through the railroads and mineral claims. Both parties and their perpetual conflicts and wars have been guilty of many human rights violations and other crimes.

- 4) Blessed are those who hunger and thirst for righteousness, because they shall be filled.
- 5) Blessed are the compassionate, because they shall obtain compassion.
- 6) Blessed are the clean in heart, because they shall see Elohim.
- 7) Blessed are the peacemakers, because they shall be called sons of Elohim.
- 8) Blessed are those persecuted for righteousness' sake, because theirs is the reign of the heavens.
- 9) Blessed are you when they reproach and persecute you, and falsely say every wicked word against you, for My sake."; and
