VOLUNTARY CONCEALED WEAPONS PERMIT ACT OF 2017

By the authority of the faith of the assembly of American Nationals, in Union under the Law of Nations, and all Acts, petitioned, accepted and acknowledged by the current United States, in Congress assembled, are hereby ordained for the safety and security of our posterity, enact the following:

SUBJECT MATTER OF THE ACT

The **VOLUNTARY CONCEALED WEAPONS PERMIT ACT OF 2017** is being offered by the United States, in Congress assembled for the purpose of limiting the liability of a possible accidental weapons discharge outside of a privacy area that may endanger the Public at Large.

BE IT ENACTED, by the United States, in Congress assembled, **VOLUNTARY CONCEALED WEAPONS PERMIT ACT OF 2017, IS HEREBY ESTABLISHED, PUBLISHED AND ACKNOWLEDGED** on the 173rd day, in the year of Yahweh, 6019,

REGULATIONS-PENALTIES OF THE ACT

The permit holder will receive a quiz that is no less than 10 questions regarding the subject matter of human rights to qualify for the permit.

The terms and conditions of the permit shall serve as a document that recognizes the intangible property right to the right of self defense and the intangible property right to conceal the weapon from the public to uphold the human right to privacy and the human right of freedom from persecution that open carry creates due to the communist party agenda.

The American National Union of The United States of America shall have the right to adopt this Act.

Bonding

The permit holder shall enjoy the right to transfer the intangible property right to the office of the Treasury for the Government of The United States of America and in return the intangible property right shall be valued in the amount of seven-hundred and fifty thousand Continental Dollars.

The surety bond shall be redeemable upon a valid claim of damages against the principle.

The third party holder of the bond shall be the Continental Public Bank as agent.

SURETY BOND

KNOW ALL MEN BY THESE PRESENTS,

That we, the trustee of _____, as principal, and the office of the Treasury for the Government of The United States of America, an authorized office within the Government of The United States of America (hereinafter, called surety) are held and firmly bound unto the Government of The United States of America, the General Post Office, the General Post Master Council, the committee of financial services as issuing agent and elected office holders, and their elected successors in office, and all persons suffering any loss or damage occasioned by the principal failing to comply with any of the provisions of any part of the Universal Declaration of Human Rights, and regulations applicable to the work performed by the principal, in the sum of +750.000.00, respective heirs, executors, administrators, successors and assigns, jointly and severally, firmly by these presents.

Any person desiring to engage in the business of private business,

The trustee shall first file with the office of the Treasury a surety bond in the sum of + 750,000.00 payable to the Government of The United States of America in the form of intangible property conveyed by quit claim deed and recorded in the Office of Deeds and Recordings, and conditioned on the faithful performance of all of the provisions of the Universal Declaration of Human Rights and the Voluntary Concealed Weapons Permit Act of 2017, and the principal on such bond shall be authorized to transact business within The United States of America under the Voluntary Concealed Weapons Permit Act of 2017.

Failure of the Principal to comply with the provisions of the Universal Declaration of Human Rights and the Voluntary Concealed Weapons Permit Act of 2017 obligates the surety to remediation or restitution of the violations up to the amount of the surety bond.

It is understood and agreed that the surety may cancel this bond at anytime on 30 days notice in writing to the Government of The United States of America, office of the Governor, but is hereby expressly provided that such cancellation shall not affect any accrued liability on the bond.

The term of this bond shall be three years from the effective date and may continue for one year from the expiration thereof by the execution of a continuation certificate by the surety or the agent

General Provisions:

- 1: The trustee of the private membership association shall be the principal under this bond.**
- 2: The office of the Treasury for the Government of The United States of America is the surety holding and the agent is responsible for maintaining the status of the surety bond, yearly reviews, and notifying the trustee of any outstanding liabilities.**
- 3: The trustee performs certain duties and responsibilities in its private business under the permit agreement within the Universal Declaration of Human Rights and the Voluntary Concealed Weapons Permit Act of 2017 and is bound by those conditions.**
