## FOREIGN TRADE AND COMMERCE ACT OF 2017

By the authority of the faith of the assembly of American Nationals, in Union under the Law of Nations, and all Acts, petitioned, accepted and acknowledged by the current United States, in Congress assembled, are hereby ordained for the safety and security of our posterity, enact the following:

### SUBJECT MATTER OF THE LAW ENACTED

The Subject Matter of the Foreign Trade and Commerce Act of 2017 is to uphold, according to The Law of Nations and the Articles of Confederation as amended, the obligations of The United States of America to her people the Right of buying and selling goods and services that are in need and can not be found, manufactured or procured within the metes and bounds of The United States of America for fair and equitable price, and

**WHEREAS**, every country has the Right to prohibit the entrance of foreign merchandises, and any nation that is affected by such prohibition is not with any claim otherwise, and

**WHEREAS**, it is the right of any country to determine its trading partners, and sovereign States may, by their promises, enter into a perfect obligation with respect to each other, and

**THEREFORE BE IT RESOLVED**, a country not having naturally a perfect Right to carry on a commerce with another, may procure it **ONLY** by an agreement or treaty, and

**FURTHER BE IT RESOLVED**, as every country has a Right to choose whether she will or will not trade with another, and on what conditions, if one country has for a time permitted another to come and trade in the country, she is at liberty, whenever she thinks proper, to prohibit that commerce, to restrain it or to subject it to certain regulations, and

**FURTHERMORE BE IT RESOLVED**, since The United States of America is under obligation to trade together with other countries for the common benefit of the human race, The United States of America remains at liberty to consider, in particular cases, whether it be convenient for her to encourage or permit commerce; and as her duty to her people is paramount to her duties to others. If The United States of America finds herself in such circumstances that she thinks foreign commerce dangerous to the country, she may **RENOUCE** and **PROHIBIT** it, and

**SO BE IT ENACTED**, the Right of commerce is a Right of mere ability, *jus merae facultatis*, and consequently is imprescriptible.

## REGULATIONS-PENALTIES OF THE ACT

### Authority

As per the Articles of Confederation, as amended on August 5<sup>th</sup>, 2015;

### Section 7; Foreign Business

All Foreign Business offers shall be sent to the Governor for the United States, in Congress assembled after going through the Secretary of State for The United States of America and recorded on the Public Record. The United States of America is required to set a standard of rules that Foreign Business must comply with in order to do Business with the American Nationals. The Governor for The United States of America shall uphold the set of standards and rules as required by the National assembly. The Government of The United States of America shall have the authority to make Laws that govern the set of standards. The counties shall govern themselves through social compact agreement by and between the residents and the body politic for that county.

### Section 5

The United States, in Congress assembled shall have the power to regulate foreign entities within The United States of America.

## *Article V Legislative Branch*

*Section 1; All limited legislative Powers herein granted by the American Nationals for The United States of America shall be vested in the United States, in Congress assembled which shall consist of delegates elected. The General purpose of the United States, in Congress assembled is to legislate the business activities of General Post Office while doing business in The United States of America or in a foreign State.*

### **Regulation**

All foreign entities to The United States of America wishing to do business within the metes and bounds thereof **MUST** join their business or entity with the USC Chamber of Commerce.

All foreign entities shall comply fully with The Foreign Agent Registration Act of 2017,

### **Intent:**

The intent of this act is to remove all presumption of a perfect right of foreign entities to conduct business within the metes and bounds of The United States of America under the imprescriptible power of *jus merae facultatis*

### **Punishment:**

Any entity found to be operating within the metes and bounds of The United States of America and not properly registered with the USC Chamber of Commerce will be renounced and prohibited from further activities and the entity in question will be subject to dissolution under the Involuntary Dissolution Act of 2015, and

**SO BE IT ENACTED** by the United States, in Congress assembled convened on the 179<sup>th</sup> day in the year of YHWH 6019,

The Government of The United States of America reserves the right to alter or amend this **ENACTMENT** and **REGULATIONS** for the exclusive purpose and in the exclusive interests of the affirmed American Nationals.
