THE PARDON AND EXONERATION ACT OF 2013 AS AMENDED 03-04-2019



ENACTMENT CLAUSE

By the authority of the faith of the assembly of American Nationals, in Union under the Law of Nations, and all Acts, petitioned, accepted and acknowledged by the current United States, in Congress assembled, are hereby ordained for the safety and security of our posterity, enact the following:

SUBJECT MATTER OF THE LAW ENACTED

The United States, in Congress assembled accepts and acknowledges the power of the people to pardon and exonerate anyone of the people for The United States of America for any non-injury accusation within The United States of America. Although, these powers are broad in scope, the United States, in Congress assembled accepts and acknowledges that the Government of The United States of America is needed in these matters when dealing with foreign governments or corporations.

For this document does not affect the validity of any previous act in a negative manner by the United States, in Congress assembled nor does it make those previous acts null and void for not having this wording in the titles and enactment clauses. For this document is evidence of a complete structure working in harmony with one another and is evidence of the expansion of a Government into an independent sphere.



Therefore, BE IT DELEGATED, by the United States, in Congress assembled that the following bodies within the Government of The United States of America shall be delegated the power to pardon and exonerate anyone of the people regardless of jurisdiction and venue for the purpose of reducing any type of corruption within the Government of The United States of America and the country under the Law of Nations, and

1. the United States, in Congress assembled
2. the office of the Governor for the Government of The United States of America
3. The General Post Master Council for Government of The United States of America
4. A three General Post Master panel in accordance with the General Post Office Articles.
5. the office of the Secretary of State for the Government of The United States of America.
6. The committee of the National assembly for the Government of The United States of America

REGULATIONS OF THE STATUTE ENACTED

IT IS FORBIDDEN for anyone to violate International law and the Law of Nations. Pardon and Exoneration must be met with clear evidence that the pardoned and exonerated are in fact innocent of the subject matter of the accusation(s) and all facts are published in a publication of record, and
