FURTHER BE IT RESOLVED, wherein the aforementioned PERSON or entity shall provide for their own safety through our Father in Heaven, through Yahushua; and

The National assembly having addressed all other motions and resolutions on the agenda file name 20200316 Agenda for the National assembly; and

BE IT RESOLVED, the meeting for the National assembly adjourned on the 363rd day, in the year of Yahweh, six thousand and twenty one, translation 16th day of March, two thousand twenty, at 9:50 Universal Time -6 to re-convene at a future date certain.
