On this **103rd day in the year of Yahweh, six thousand and twenty two**, and the 29th day of June two thousand and twentieth year of the new covenant in Yahushua's name, at 7:00 Universal Time -6, the American Nationals for the Government of The United States of America, and all other interested persons convened a meeting for the assembly, identified as **20200629-SOS-OAR_**.

Official Assembly Record

BE IT RESOLVED, that a motion was passed that any capitalist, regardless of status, has the authority to arrest any Marxist under the Communist Control Act of 1954 or the Expatriation Act of 1954 or the Communist Expulsion Act of 2019; and

FURTHER BE IT RESOLVED, the arrested Marxist will be handed over to the Sheriffs regardless of affiliation whether a member of **ANTIFA**, **BLACK LIVE MATTER (BLM)**, Council on American-Islamic Relations (**CAIR**) or any other Marxist of organization; and

FURTHER BE IT RESOLVED, anyone that bails out or any Sheriff that releases the arrested Marxist will be considered a Marxist, therefore published as a treasonous traitor; and

FURTHER BE IT RESOLVED, any force used by a capitalist to protect private property is hereby authorized under the castle doctrine regardless of State wherein the incident occurs; and

FURTHER BE IT RESOLVED, force means wound if necessary after warning, and if met with lethal force may use lethal force under right of defense. Anyone forcing their way into any privately owned business or home, destroying private property, setting private property on fire, damaging buildings and property in anyway may be arrested immediately by any capitalist within the area and turned over to the Sheriff; and

FURTHER BE IT RESOLVED, all force is met with equal or greater force to protect private property; and

The National assembly having addressed all other motions and resolutions on the agenda file name 20200629 Agenda for the National assembly; and

BE IT RESOLVED, the meeting for the National assembly adjourned on this 103rd day in the year of Yahweh, six thousand and twenty two, and the 29th day of June two thousand and twentieth year of the new covenant in Yahushua's name, **at 9:35 Universal Time -6** to re-convene at a future date certain.
