JUDGMENT



Comes now, a Judgement and Order from the **War Crimes Tribunal for The United States of America.**

WHEREAS, the claimant has claimed within the evidence submitted to the tribunal through a published International True Bill of Indictment, the Respondent committed war crimes by violating Article 1 of the Nuremberg Code, and violation of all Thirty (30) Articles of Public Laws-101, Violating Article 20 (2) of the International Covenant on Civil and Political Rights and Violating Article 31 of the Bi-Lateral Social Compact Agreement by and between the people for The United States of America (International Terrorism), and

WHEREAS, the Respondent is in default having failed to respond and address the claims set forth by the Claimant within the published International True Bill of Indictment in any form, [LINK](#) on the 196th Day in the Year of Yahweh 6023, translation date October 1st, 2021. The Respondent is in dishonor and therefore is in omission to the war crimes presentment of the Claimant, and

WHEREAS, the Tribunal has examined all evidence and deliberated the elements of the case brought forth by the Claimant with fairness in non-arbitrary sentencing. The War Crimes Tribunal for The United States of America has the legal obligation to ensure that the most severe crimes of concern to The United States of America and the International community do not go unpunished and are not in conflict with the *Law of Nations*, and

WHEREAS the Tribunal finds respondent guilty of violating Article 1 of the Nuremberg Code for publicly promoting experimental Gene Therapy “operating system” a medical experiment disguised as vaccination injections [LINK](#), and

Nuremberg Code -The voluntary consent of the human subject is absolutely essential. This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, overreaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision. The latter element requires that before the acceptance of an affirmative decision by the experimental subject there should be made known to him the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonably to be expected; and the effects upon his health or person which may possibly come from his participation in the experiment.

WHEREAS, the Tribunal finds the Respondent guilty of violating Article 20 (1) of the International Covenant on Civil and Political Rights, for promoting war propaganda in a contrived war effort against an invisible enemy, nefariously using experimental injections, thereby committing an act of International Terrorism against the civilian inhabitant populace and the permanent population of The United States of America bound together in Social Compact Agreement [LINK](#), and

WHEREAS, the Tribunal finds the Respondent guilty of Violating Article 31 of the Bilateral Social Compact Agreement by and between the people for The United States of America, committing an act of International Terrorism wherein the Respondent advocates and defends the use of CDC’s guidelines [LINK](#) in a contrived war effort against an invisible enemy, and

WHEREAS, the Tribunal finds the Respondent engaged in covert deceptive practices to coerce the civilian inhabitant populace to comply with gene therapy “operating system” a medical experiment disguised as a vaccine containing nano technology and cell lines from human fetal tissue in violation of the Nuremberg Code and all Thirty (30) Articles of Public Laws-101, and

WHEREAS, the Tribunal agrees that the Respondent is, as press secretary, the spokesperson for the communist agenda, and an instrument of a dictatorial order, enforcing the communist depopulation Agenda 21 and Agenda 30, thereby aiding and abetting the act of genocide, and the annihilation of the civilian inhabitants’ human rights to complete the One World Government’s totalitarian takeover carved in stone and on display on the Georgia Guide stones [LINK](#), and

WHEREAS, the Tribunal agrees to find the Respondent guilty of committing war crimes for aiding and abetting the globalist communist genocidal depopulation agenda by violating the public trust, through deception in advocating for the mandate of gene therapy injections that have led to the death of over 9,048 civilian inhabitants [LINK](#), and

JUDGMENT

NOW, THEREFORE, BE IT JUDGED, UPON DUE CONSIDERATION, IT IS HEREBY ADJUDGED, ORDERED AND DECREED, that Respondent Jennifer Rene Psaki has been found guilty of advocating genocide and is actively following a common plan to perpetrate war crimes and crimes against humanity as part of the globalist communist Agenda 21 and 30, a New World Order agenda consisting of a one world communist government and pre-meditated and well-constructed global depopulation agenda by claiming medical power of attorney for the civilian inhabitant populace, and

ORDERS

BE IT ORDERED, a Federal Common Law Lien in the amount of Five Hundred Million (+500,000,000) in Silver Certificates or equivalent will be published in the American Herald Newspaper and placed on Respondent, Jennifer Rene Psaki's person and personal property.

BE IT ORDERED, Respondent is hereby immediately exiled and deported from the metes and bounds and seaward boundaries of The United States of America, and

BE IT ORDERED, Respondent will receive the death penalty and face a firing squad if Respondent returns to The United States of America.

BE IT ORDERED, anyone offering aid and comfort to the Respondent shall be subject to the FORCED DEPORTATION ACT OF 2021 as an enemy of the country. [LINK](#)

BE IT ORDERED, that the named Respondent is in violation of all Thirty (30) Articles of the Universal Declaration of Human Rights, and in violation of all Thirty (30) Articles of Public Laws-101. The violation of all Thirty (30) Articles of the Universal Declaration of Human Rights has been assessed at a value of Twenty-two Million Five Hundred Thousand (+22,500,000).



FURTHER BE IT ORDERED, that this Judgment and Order be sent to the office of the Treasury for The United States of America, Global Postal Code: NAC: 850H2 MR7C8-0007, The United States of America for the purpose of attaching a Declaration of Value for the monetary damages associated with violations of all Thirty (30) Articles of the Universal Declaration of Human Rights.

ORDERED THIS 214th Day in the Year of Yahweh 6023, translated the 19th day of October in the Two Thousand and Twenty-first year of the new covenant in Yahushua's name.
