BE IT RESOLVED, that a motion passed by the National assembly to outlaw the use of an ICD 10 Code or any other code to identify the vaccinated or unvaccinated, and

BE IT RESOLVED, a motion passed by the National assembly to amend Public Law 101-26-2 from "Education shall be directed to the full development of the human personality and to the strengthening of respect for human rights and fundamental freedoms. It shall promote understanding, tolerance and friendship among all nations, racial or religious groups" to "Education shall be directed to the full development of the human personality and to the strengthening of respect for human rights and fundamental freedoms including exemption from experimentation. It shall promote understanding and friendship among all nations, racial or religious groups, and children shall have standard teaching practices (reading, writing, math, history, physical and natural world study, physical education), free of all other agendas.", and
