On the 2nd Day in the year 6018 at 10:00PM UTC-6 the United States, in Congress assembled convened to consider and act on the following matters:

1. To determine if the form PA-28, entitled" NEW HAMPSHIRE DEPARTMENT OF REVENUE ADMINISTRATION - 2016 INVENTORY OF TAXABLE PROPERTY - AS REQUIRED BY RSA 74 - DUE ON OR BEFORE APRIL 15TH ", is human rights compliant, and

FINDINGS

Form PA-28 is not human rights compliant due to multiple violations of Articles of the Universal Declaration of Human Rights, and

The following Letter of Protest shall be recorded and a certified copy sent to the U.S Secretary of State John Kerry and the New Hampshire Secretary of State William M. Gardner to wit;



Registered with the **IP Rights Office** Copyright Registration Service Number: 4056990103 "This letter serves as an official Protest from the United States, in Congress assembled in reference to the attached form PA-28 entitled "NEW HAMPSHIRE DEPARTMENT OF REVENUE ADMINISTRATION - 2016 INVENTORY OF TAXABLE PROPERTY - AS REQUIRED BY RSA 74 - DUE ON OR BEFORE APRIL 15TH", hereinafter form PA-28, and

After reviewing form PA-28, a determination has been made by the United States, in Congress assembled, with full authority to regulate foreign businesses within the metes and bounds of The United States of America as per the Articles of Confederation, as amended in convention on August 5th 2015 that;

- form PA-28 submits the people to slavery through false and misleading statements namely "Census" while the form is intended to report inventory of the Bank of New York Mellon, and
- 2. signing form PA-28 under penalty of perjury is designed to place people under perpetual debt to the Bank of New York Mellon that exists in a foreign nation of Manhattan Island. Manhattan Island is under the charter of the patroons and under direct control of the King of the Netherlands. PA-28 converts the township and or city into a forced labor camp under a foreign jurisdiction that does not have State and federal constitutional protections in place to stop the forced labor of the people, and
- 3. imposing a fine for not filing a form PA-28 forces people under duress to enslave themselves to a private central bank and inventory of the Bank of New York Mellon, and

THEREFORE, form PA-28 is a violation of the Universal Declaration of Human Rights under;

Article 4 No one shall be held in slavery or servitude; slavery and the slave trade shall be prohibited in all their forms, and Article 15 1. Everyone has the right to a nationality, and Article 20 2. No one may be compelled to belong to an association, and

BE IT RESOLVED by the United States, in Congress assembled, that form PA-28 and forms like PA-28 are hereby dissolved, and further, the statutes that govern PA-28 are notwithstanding. Further, any and all townships and cities are required to register assets with the Treasury of the United States or the office of the Treasury for the Government of The United States of America, and



FURTHER, BE IT RESOLVED, that the organization and individuals that created PA-28 are considered international fugitives from justice and hereby classified International Human Rights Violators,

SO ORDERED by the United States, in Congress assembled on this 3rd Day in the year of Yahweh six thousand and eighteen, translation 22nd day of two thousand and sixteen, and.."

The meeting of the United States, in Congress assembled is adjourned on this 2nd Day of the year 6018 at 11:00PM UTC -6 to reconvene at a future date certain and,
