# **JUDGMENT**

Comes now, a Judgement and Order from the War Crimes Tribunal for The United States of America.

WHEREAS, the Claimant has claimed within the evidence submitted to the Tribunal through a published International True Bill of Indictment and presentment of facts, that the Respondent committed war crimes by violating Article 1 of the Nuremberg Code, violations of all Thirty (30) Articles of Public Laws-101, and violations of Article 20 (1) and Article 20 (2) of the International Covenant on Civil and Political Rights. and

WHEREAS, the Respondent is in default having failed to respond and address the claims set forth by the Claimant within the published International True Bill of Indictment <u>LINK</u> in any form on the 210th Day in the Year of Yahweh 6023, translation date October 15<sup>th</sup>, 2021. The Respondent is in dishonor, and therefore is in omission to the war crimes presentment of the Claimant, and

WHEREAS, the Tribunal has examined all evidence and deliberated the elements of the case brought forth by the Claimant with fairness in non-arbitrary sentencing, the War Crimes Tribunal for The United States of America has the legal obligation to ensure that the most severe crimes of concern to The United States of America and the International community do not go unpunished and are not in conflict with the Law of Nations, and

WHEREAS, the Tribunal agrees and previously declared the American British Accredited Registry (B.A.R.) Association also known as American Bar Association, (hereinafter "A.B.A.") as a criminal organization, that has established a private legal society granting themselves separate privileges, using foreign emoluments, and

operates outside of their scope of existence as an association, wherein the aforementioned association nefariously attempts, through appointed figureheads, to govern as a State of a person of International Law, committing acts that rise to the level of capital crimes against the American society, having claimed the legal obligations of a State, <u>LINK</u> in violation of Article 1 of the Montevideo Convention, wherein it states:

"The state as a person of international law should possess the following qualifications: (a) a permanent population; (b) a defined territory; (c) government; and (d) capacity to enter into relations with the other states.", and

WHEREAS, the Tribunal agrees and finds the A.B.A., its members, and representative bodies, which have hijacked the legal obligations of a State without a Social Compact agreement in violation of the *Law of Nations*, have infiltrated public institutions, appointing themselves as slave masters over the civilian Inhabitant populace through communist doctrine and are now actively advocating for the lawfulness to inject experimental biological weapon systems defined as Gene Therapy <u>LINK</u> into the civilian inhabitant populace, under the guise of a vaccine, and

WHEREAS, the evidence presented to the Tribunal conveys that the Respondent believes that the civilian inhabitant populace fall under the classification of subjects of medical experimentation, and is advocating on behalf of terrorist organizations <u>LINK</u>, such as the Food and Drug Administration and the Center for Disease Control and Prevention, to claim medical power of attorney over families, thereby infringing upon the aforementioned populace's intangible property rights, to determine what is best for their health and well being through forced association and denying the right to private property, and

WHEREAS, the Tribunal agrees and finds Respondent guilty of violating Article 1 of the Nuremberg Code for publicly promoting an experimental Gene Therapy "operating system" through medical experimentation disguised as vaccination inoculations <u>LINK</u>, and

Article 1 Nuremberg Code - The voluntary consent of the human subject is absolutely essential. This means that the person involved should have legal capacity to give consent; should be so situated as to be able to exercise free power of choice, without the intervention of any element of force, fraud, deceit, duress, overreaching, or other ulterior form of constraint or coercion; and should have sufficient knowledge and comprehension of the elements of the subject matter involved as to enable him to make an understanding and enlightened decision. The latter element requires that before the acceptance of an affirmative decision by the experimental subject there should be made known to him the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonably to be expected; and the effects upon his health or person which may possibly come from his participation in the experiment.

WHEREAS, the Respondent is engaged in manipulative religious and political dialectic to deceive and coerce the civilian populace as part of an ongoing covert psychological warfare operation, the Respondent is using known Marxist communist ideological subversion tactics <u>LINK</u> to destabilize society through manufactured crisis, thereby changing the perception of reality to the desired new normal, being a totalitarian globalist communist takeover of the secular society in violation of all Thirty (30) Articles of Public Laws-101, <u>LINK</u>, and

WHEREAS, the Tribunal agrees and finds the Respondent guilty of supporting acts of terrorism, therefore violating all Thirty (30) Articles of Public Laws-101, for discriminating and for creating fear and disarray among the population through communist propaganda for the purpose of depriving the civilian inhabitant populace of private property rights, and

WHEREAS, the Tribunal agrees and finds the Respondent to be a communist agent and an instrument of a dictatorial order, enforcing the communist depopulation Agenda 21 and Agenda 30, thereby joined in

## **JUDGMENT**

NOW, THEREFORE, BE IT JUDGED, UPON DUE CONSIDERATION, IT IS HEREBY ADJUDGED, ORDERED AND DECREED, that Respondent Donald J. Polden is guilty of committing war crimes, and supporting acts of terrorism, guilty of aiding and abetting the globalist communist genocidal depopulation agenda through current biological warfare operations, which deprive civilian inhabitants of life, security, liberty, and pursuit of happiness, therefore violating the *Law of Nations*, the Nuremberg Code and all Thirty (30) Articles of Public Laws-101, and

#### **ORDERS**

BE IT ORDERED, that the Respondent have a Federal Common Law Lien published in the American Herald Newspaper and placed on Respondent's person, real and personal property in the amount of Seven Hundred and Fifty Million U.S. (\$750,000,000) dollars.

BE IT ORDERED, Respondent and their spouse(s) or civil, marital partner(s) are hereby immediately exiled and deported from the metes and bounds and seaward boundaries of The United States of America.

BE IT ORDERED, Respondent will receive the death penalty and face a firing squad if Respondent returns to The United States of America.

BE IT ORDERED, that the Respondent is in violation of all Thirty (30) Articles of the Universal Declaration of Human Rights, and in violation of all Thirty (30) Articles of Public Laws-101. The violation of all Thirty (30) Articles of the Universal Declaration of Human Rights has an assessed value of +22.5 million.

FURTHER BE IT ORDERED, that this Judgment and Order be sent to the office of the Treasury for The United States of America, Global Postal Code: NAC: 850H2 MR7C8-0007, The United States of America for the purpose of attaching a fine for the monetary damages associated with violations of all Thirty (30) Articles of the Universal Declaration of Human Rights.

BE IT ORDERED, anyone offering aid and comfort to the Respondent is subject to the FORCED DEPORTATION ACT OF 2021 as enemies of the country. <u>LINK</u>

ORDERED THIS 227th Day in the Year of Yahweh 6023, and the 1st day of November, two thousand and twenty first year of the new covenant in Yahushua's name.
