BE IT RESOLVED, a motion to charge the Boston Mayor, the Governor of Massachusetts and all other associating Respondents with war crimes for violating Article 1 of the Nuremberg Code, Slavery and other charges that may apply, and

BE IT RESOLVED, a motion to classify the syringe, vaccine nasal spray, vaccine patches, and covid vaccine pills, with any form of a covid vaccine in it, as a bio lethal weapon wherein anyone has the right to self-defense up and including lethal force to stop it from penetrating the skin and the bio weapon being discharged, and

BE IT RESOLVED, a motion passed by the National assembly to extend some authorities from Treasury over to the bank, and

BE IT RESOLVED, the meeting for the National assembly adjourned on the 283rd day, in the year of Yahweh, six thousand and twenty third, translation 27th day of December, two thousand and twenty one, at 8:16 Universal Time -6 to re-convene at a future date certain.
