BE IT RESOLVED, a motion to accept all other IDs the ANU has previously issued, and

BE IT RESOLVED, a motion to use ALLWRIGHT ENTERPRISES LLC as the vendor for printing the DL, IDs, and passport cards, and

BE IT RESOLVED, a motion to forcefully deport Senator Richard Pan, California, in accordance with the Forced Deportation Act of 2021, for attempting to pass legislature that may subject the civilian inhabitant populace to communism and mandated experimentation of lethal biological weapons in violation of Article 1 of the Nuremberg Code, and

BE IT RESOLVED, a motion to transfer all right title and interest of the original union of 1774 over to the GPU of The United States of America, and

BE IT RESOLVED, a motion to transfer all members, all work that's been done, and any unions that have been created any and other – all equity over to the general post union, and

BE IT RESOLVED, a motion to transfer all businesses there that have memberships; just the memberships only. The businesses remain in the hands of all the people that own them for the entities that they own. No ownership will be accepted by the GPU of The United States of America, and

BE IT RESOLVED, the meeting for the National assembly adjourned on the 9th day, in the year of Yahweh, six thousand and twenty four, translation 21st day of March, two thousand and twenty two, at 8:41 Universal Time -6 to re-convene at a future date certain.
