BE IT RESOLVED, a motion - Charles Scarborough and Carl Stewart subject to the Forced Deportation Act of 2021. James Dennis took senior status and was arbitrarily used as a third vote by Stewart to reinstate the mandate, and

BE IT RESOLVED, a motion to create a Securities and Exchange Committee, and

BE IT RESOLVED, a motion to classify the members of the LGBTQ+ Baal Peor religious community as mentally defective as defined herein; Mentally defective means that a person suffers from a mental disease or defect which renders that person temporary or permanently incapable of appraising the nature of his or her conduct and is a danger to oneself or others, and

BE IT RESOLVED, a motion to deport Philadelphia Mayor Jim Kenney and city of Philadelphia health commissioner Cheryl Bettigole for enforcing mask mandates upon the inhabitants of Philadelphia, and

BE IT RESOLVED, the meeting for the National assembly adjourned on the 30th day, in the year of Yahweh, six thousand and twenty four, translation 18th day of April, two thousand and twenty two, at 8:44 Universal Time -6 to re-convene at a future date certain.
