On the 16th day of **September** in the year **2015**, at 7:00 PM Central, The Nationals and RESIDENTS for The United States of America, and all other interested persons convened a meeting for the assembly, identified as **20151116-SOS-OAR**.

Official Assembly Record

BE IT RESOLVED, that a motion was carried by the assembly of Affirmed American Nationals to extend membership to all, including those without an American National Oath or Affirmation to join the Government organization Human Rights Defenders International; and

FURTHER BE IT RESOLVED, the newly proclaimed Human Rights Defenders are to take testimony and report to the Human Rights Defenders International and are not to act as agents in court cases; and

BE IT RESOLVED, the Secretary for the Human Rights Defenders International read into the Official Assembly Record the *“Proclamation to stand with the Government of The United States of America for the preservation of human rights that preserves human life”*; and

BE IT RESOLVED, that a motion was carried by the assembly of Affirmed American Nationals that the Government of The United States of America does not require a Driver’s License for American Nationals; and

FURTHER BE IT RESOLVED, that the Government of The United States of America is relieved from having to attempt to procure a reciprocity agreement with other foreign states; and



FURTHER BE IT RESOLVED, registration is not required; however bonds for injuries are required and shall be secured by the affirmed American National by the value of the oath or affirmation; and


FURTHER BE IT RESOLVED, that registrations of Automobiles shall be accompanied with a copyright and possible trademark secured to the owner of the Automobile by the Government of The United States of America in accordance to its Declaration of Sovereignty; and

BE IT RESOLVED, that a motion was carried by the assembly of Affirmed American Nationals that collecting of funds for foreign issued traffic tickets issued to American Nationals by foreign states will be presented to the General Post Master Council via email at: gpmcouncil@generalpostoffice.international or to the clerk; and

FURTHER BE IT RESOLVED, the General Post Master Council, upon presentment will open a case for collections and collect the amount in Continental Dollars from the American National and thereby forwarded to the claimant; and

BE IT RESOLVED, the meeting for the assembly adjourned on this 16th day of **November in the year 2015, 8:00 PM** to re-convene at a future date certain.
