Official Assembly Record

BE IT RESOLVED, a motion to charge the Board of Trustees of the World Economic Forum with Aiding and Abetting war criminal Pfizer CEO Albert Bourla and others, violating Article 1 of the Nuremberg Code (War Crime) for financing the distribution of prototype biological weapons, Social Engineering (War Crime) as evidenced at the 2022 Davos Agenda, Genocide (War Crime) for the aforementioned, and Infiltration/International as admitted by Klaus, himself, and

BE IT RESOLVED, a motion for the Driver's License and any other form of Identification that the Government for The United States of America offers to expire at the 3 year mark for Declared residents that have not yet claimed their Nationality by taking an affirmation as an American National, and

BE IT RESOLVED, a motion to table tonight's meeting (July 4, 2022) to next Monday night (July 11, 2022), to spend time with family and anything pressing business this week to be handled on telegram, and

BE IT RESOLVED, a motion to adopt the name change of resident ID number to National ID number once a person has taken the Oath/Affirmation to become an American National, and

BE IT RESOLVED, a motion to change Resident ID # to National ID # on the Driver's License when a resident takes an Oath/Affirmation to be an American National, and

BE IT RESOLVED, a motion to move the Continental Bank and the dot com website offshore; and

BE IT RESOLVED, the meeting for the National assembly adjourned on the 114th day, in the year of Yahweh, six thousand and twenty four, translation 11th day of July, two thousand and twenty two, at approximately 8:34 Universal Time -6 to re-convene at a future date certain.

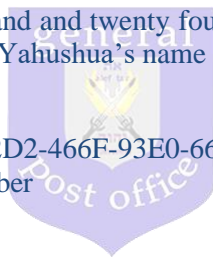
