I, **Jason Westley Hall**, the undersigned inscriber, affirm that I will be faithful and bear true allegiance to The United States of America, a Nation unto itself, and a republic form of Government, and as a free and Independent Nation as long as the law of free will and choice is respected and upheld as established by the one true source; and that I will not at any time do or cause to be done, any matter or thing, that will be prejudicial or injurious to the freedom and Independence thereof; and, **also**, that I will discover and make known to the General Post Office while holding the office for the General Post Master for The United States of America all treasonous or traitorous conspiracies which I now have or hereafter shall know to be formed against The United States of America. I will also abide by the Articles of Confederation for The United States of America, as amended, and The Articles of Confederation, agreed to by in Congress assembled, November 15th, 1777, ratified and in force March 1st, 1781, brought forward to the present time, The General Post Articles, as amended and all other documents ratified and amended, now therefore,

So solemnly affirmed, declared, and promised on the 47th day in the year of Yahweh, six thousand and twenty-four; and the two thousand and twenty second year of the new covenant in Yahushua's name.
