**BE IT RESOLVED**, a motion for the Social Assistance Account Manager for General Post Office Division 3 to help carry out the obligations of THE SOCIAL ASSISTANCE ACT OF 2015 under the REGULATIONS OF THE STATUTE ENACTED brought forward by the United States, in Congress assembled affirmed on THE 20TH DAY, OF MARCH IN THE YEAR 2015 or to the best of the Social Assistance Account Mangers ability, and

**BE IT RESOLVED**, a motion to OUTLAW THE UNITED STATES CORPORATION'S PREP ACT AND H.R. 5546 DISTRIBUTING AND ADMINISTERING VACCINATIONS FOR PERSONS UNDER THE AGE OF MATURITY, and

**BE IT RESOLVED**, a motion to amend the General Post Union constitution and by-laws: Section A adding the word 'voting' is restricted; and Section B 1. B) to read: Declared resident must have the existence published in the Legal Notices of the North American National Party website, and

**BE IT RESOLVED**, a motion to establish departments within the General Post Union for such purposes as it deems necessary, and

**BE IT RESOLVED**, a motion to change the term 'pedophile' to 'rapist' and treat them as such, and

**BE IT RESOLVED**, a motion to purchase a printer that treasury deems is appropriate, and

**BE IT RESOLVED**, a motion to remove any and all printing authority away from the president, and

**BE IT RESOLVED**, a motion to remove any and all access to GPOD3 and its office holders or anyone from the president,

**BE IT RESOLVED**, a motion to have the president forfeit all money that has already been printed, all money that has been donated, and all materials donated or that have been purchased, over to treasury, and
