



THE CONSTITUTION FOR THE AUTOMOBILE ASSOCIATION FOR THE UNITED STATES OF AMERICA AS AMENDED ON, MARCH 30TH 2022

We the members collectively and severally, serving our fellow man, hereby establish the **Automobile Association for The United States of America**. Desiring to achieve the ends and fulfill the purposes of equality and freedom for all people, the Articles of Organization are hereby established for the private membership association, and

ARTICLE I NAME AND OBJECTIVES

§1.1 Name

The name of the Association shall be the "Automobile Association for The United States of America", (hereinafter referred to as "*the Association*"), and

§1.2 Objectives

The following objectives of the Association shall be but not limited to:

A. To ensure equality and freedom for all people through honest property claims and individual responsibility, and

B. Economic and Agricultural Independence, and

C. International Disaster Relief, and

D. To advocate for the improvement of the professional and dignified conditions of the membership, and

E. To engage in such other activities as may be deemed necessary and proper to further the objectives of the Association, within the limitations prescribed by the Articles of

Confederation as amended August 5th, 2015 of The United States of America and all applicable laws, statutes, regulations, rules, and Articles of professional behavior. Any and all other objectives and by-laws shall be listed in the Article of Association attached to these Articles of Organization, and

ARTICLE II MEMBERSHIP

§2.1 Eligibility

A. Executive Membership

Executive Members will have claimed their Nationality as American National. An Executive Member will have a working knowledge of Common Law, Anglo Saxon Law, Civil Law, and differences between the different forms of Government and Political structures so as to maintain the structure of the Association. An Executive Member will have a working knowledge of International Law and the Law of Nations and the differences between Commercial Activity, private activity, use of the Public Highways as a matter of right, and International Travel, and

Executive Members shall have a competent knowledge of the basic International Traffic Rules and shall be competent while in control of an Automobile within The United States of America, and

Only Active Members may be eligible as Executive Members, and

Oath or Affirmation for Executive Members for claiming a Nationality known as American National:

Declaration and Affirmation of National for The United States of America, as amended May 19, 2014

I, _______, hereunto Subscribed Do solemnly and sincerely Declare and affirm, that The United States of America is and of right ought to be a free Sovereign and Independent Nation—and I do forever renounce all Allegiance, Subjection and Obedience to the Three-City Empire which consists of the City of Washington D.C., City of London, and Vatican City, and I do further solemnly, sincerely and truly declare and affirm that I never have since the declaration of Independence, directly or Indirectly aided, assisted, abetted or in any wise countenanced the Three-City Empire consisting of the City of Washington D.C., City of London, and Vatican City, its Generals, fleets or armies; Allegiance or their adherents in their claims upon these United States, and that I have ever since the declaration of the Independence thereof

demeaned myself as a faith full citizen, subject or resident of this or some one of the United States, and that I will at all times maintain and support the freedom, sovereignty and Independence thereof, on my honor, and

Further, I, _____, will also abide by the original organic laws for The United States of America and The Articles of Confederation, as amended on August 5th, 2015, and

Further, I, ______, hereby accept and acknowledge that my particular Nationality carries with it separate and equal station with Nationals in "one of the United States" within the original Union, so that my Nationality shall have standing among all other Nations and States in The United States of America or otherwise, and

Further, I, ______, hereby accept and acknowledge that the status of my Nationality carries with it the aforementioned established current condition, even in the event that some other "one of the United States" is populated with a particular National of a particular "one of the United States" within the original Union, and

Further, I,_______ hereby accept and acknowledge that "One of the United States" includes all fifty States, entitled to equal footing with the original 13 States, ratified and in force July 13, 1787 through the Northwest Ordinance, brought forward to the present time, and

Therefore, I, ______, hereby accept and acknowledged that my particular Nationality is counted as one of a permanent population of all fifty "one of the United States" within the metes and bounds of The United States of America, and

All these words I speak, I promise, and So solemnly affirmed, declared and promised on the _____ day of ______, two thousand and ______,

B. Associate Membership as organizations.

Members endorsing the Association's objectives but not qualifying for Executive Membership or active membership may become associate members and shall be entitled to annual and special reports and newsletters published by the Association. Associate members may attend meetings of the membership and the Executive Committee in the name of the Associates organization and as a representative thereof, but do not have the right to vote or hold office. An Associate member must have the name of its organization attached to a publication as an entity existing within The United States of America wherein the entity is published once a day for three days under Public Notice in a newspaper. The applicant shall contact the Minister of Trusts for requesting a publication at <u>ministers@reignoftheheavenssocietytemple.com</u>, and

C. Active Membership

Active membership consists of Trusts or other organization, established by publication in a newspaper, and

The Active members voting shall be known as trustees, and are eligible to vote and participate in all activities of Association, as written within the Articles of Association, and

§2.2 Termination of Membership

Membership in this Association shall be terminated for any of the following causes:

A. By two-thirds vote of the Executive membership, upon recommendation of the active membership for violating the Criminal laws of The United States of America, and

ARTICLE III MEMBERSHIP GENERALLY

§3.1 Government

The Association shall be governed by majority vote of the active members voting and the General Post Master Council for The United States of America shall be the forum for peaceful settlement of disputes, and

A. Membership meetings shall be held annually, at a time and place determined by the Executive Committee, and

B. Special meetings of the membership may be called by the Minister of Trusts of the reign of the heavens Society Temple or by majority vote of the Executive Committee, and

C. At least ten days' notice shall be given the membership of special meetings, and **D.** A convening at any general or special meeting shall consist of ten active members, and

E. In the case of a member wherein the Trustee does not have an oath or affirmation Nationality claim, the trust shall be considered as an Associate Member and under the same terms as an Associate Member, and

ARTICLE IV EXECUTIVE COMMITTEE

§4.1 Composition

The Executive Committee shall consist of the elected officers of the Association. The Executive Committee shall be elected by majority vote at the annual membership meeting by the active members, and general

§4.2 Term of Office



Members of the Executive Committee shall each serve for a term of two years, and

§4.3 Replacement of Executive Members

Whenever any member of the Executive Committee vacates their office, the remaining Executive Members shall, by majority vote, appoint a substitute for the remainder of the term, and

§4.4 General Administration

The administration of the affairs of the Association shall be vested in the Executive Committee, which shall carry out any and all authorized recommendations and instructions emanating from the active membership in assembly, and

§4.5 Meetings

The Executive Committee shall meet quarterly, at times and places to be specified by the President. Special meetings may be called by the President or by a majority vote of the Executive Committee, at any time, upon reasonable notice to all members of the Committee. A majority of the Executive Committee shall constitute a convening for the transaction of business, an

ARTICLE V OFFICERS

§5.1 General

A. The officers of this Association shall be the President, Vice-President, Secretary, and Treasurer. Officers must be trustees of the Association in good standing, and

B. Where no candidate for an office has received a majority of the first ballot in any election, a further election shall be held between the two candidates with the highest number of votes by the active members in good standing, and

C. The President shall not serve two successive terms in such capacity, and

§5.2 Election

The officers shall be elected each year by a majority vote of the active members voting, and shall be installed to take office at the conclusion of the election upon letter of acceptance and acknowledgment, and

§5.3 Duties of the President



A. The President shall be the executive officer of the Association and shall preside at all meetings of the Association. The President may call meetings of the Executive Committee and all regular and special committees. The President shall appoint all committees except the nominating committee, and

B. In the event that any officer, committee chairman, or member of the Executive Committee is unable to serve, the President shall appoint a replacement, with the approval of a majority of the Executive Committee. The replacement shall serve until a successor is duly elected. In case of the resignation or death of the President, the Vice-President shall automatically become President for the unexpired term and a new Vice-President will be appointed by the Executive Committee upon no objections by the active members, and

C. The President shall render an annual report to the membership and may submit such recommendations as he or she deems necessary, and

§5.4 Duties of the Vice President

A. The Vice President shall serve as a member of the Executive Committee, and

B. In the event the President is unable to perform the duties of the office of President, the Vice President shall preside and perform the duties of the President, and



§5.5 Duties of the Secretary

A. The Secretary shall keep minutes of meetings of the active member meetings and of the Executive Committee, and

B. The Secretary shall assist the Treasurer as necessary with regard to maintaining a current roster of all members in good standing, and

C. The Secretary shall prepare and issue correspondence at the request of the President, and

§5.6 Duties of the Treasurer

A. The Treasurer shall be responsible for the collection of donations for the Association. He or She shall establish a bank account or accounts in the name of the Association and shall be responsible for paying all bills and expenses of the Association. The Treasurer shall submit to the President and to the Executive Committee regular statements of the condition of the treasury and shall be responsible for keeping the accounts and books of the Association. The Treasurer shall account to the membership annually and shall render a statement of the financial condition of the Association at such other times as may be requested by the President or Executive Committee, and

B. The Treasurer shall maintain a current list of the members in good standing and shall maintain a record available to the Executive Committee of the name and address of any member who is delinquent in donations. The Treasurer shall also issue to any delinquent member the notice of delinquency and shall remit a copy of said notice to the Secretary to be placed in the minutes of the meeting of the Executive Committee, and

§5.7 Joint Duties of the Officers

A. Checks on the account of the Association may be issued by the Treasurer and the President together, however, not separately, and

B. Upon direction of the President, the Secretary shall strike from the membership roles any member whom the Treasurer certifies to have been delinquent in donations for a period of more than one hundred twenty days, and

ARTICLE VI AMENDMENTS

§6.1 The Articles of Organization or the Articles of Association may be amended at an Association meeting by a vote of two thirds of those present and not present. No amendments shall have any validity in the Article of Association until all active members have voted and the amendments within the Articles of Association shall not take effect for one year from the time the amendment was approved by the active members of the Association at the time of the vote. All amendments of the Articles of Organization shall be effective immediately after the voters approval, and

ARTICLE VII STANDING COMMITTEES

§7.1 Identity of Standing Committees

Permanent standing committees of the Association shall be established subsequent to the annual membership meeting, and

§7.2 General Committee Functions

A. All committees shall be appointed by the President with the consent of the Executive Committee, and

B. The standing committees shall report to the President and the Executive Committee and to the active members in assembly, and

C. The Vice-President shall be ex-officio members of all committees created by the President, and

D. Committees shall meet upon the call of their respective chairpersons or upon the request of the President, and

E. The various standing committees shall have such duties as may be assigned to them from time to time by the President or by the Executive Committee upon petition by the active members in assembly, and

ARTICLE VIII PROCEDURE

§8.1 All proceedings

A. Executive meetings and meetings of the active members in assembly shall be conducted pursuant to the rules of the assembly for The United States of America, and **B.** Any and all Articles are subject to be changed or altered at anytime upon majority vote of the active members and shall take effect immediately upon publication of the changes or alterations, however, any changes, amendments or alterations of the foregoing Articles of Association shall take effect after one year has expired from the time of the alteration, changes or amendments are not subject to Public Notice Publication. All Articles of Association changes, alterations or amendments for the purpose of expanding the services of the Association are required to be Published within the Association Private Newsletter before a vote of active members in assembly, and


