**BE IT RESOLVED**, a motion to remove any and all access to GPOD3 and its office holders from the vice president, and

**BE IT RESOLVED**, a motion to have Jacquelyn Ellen Goudey and Gregory Thomas Johnson meet with Howard Frederick Walker III at his house at an agreed upon time to pick up and move the silver to their house. It can then be counted by treasurer Brandon Allan Anderson, Jacquelyn Ellen Goudey, Gregory Thomas Johnson, and another GPM if one is available, and

**BE IT RESOLVED**, a motion to rescind Grant request that was approved by the National assembly, the amount left being 999,757,187 that was allocated for Hawaii county assembly, and

**BE IT RESOLVED**, the meeting for the National assembly adjourned on the 170<sup>th</sup> day, in the year of Yahweh, six thousand and twenty four, translation 5<sup>th</sup> day of September, two thousand and twenty two, at approximately 8:50 Universal Time -6 to re-convene at a future date certain.
