General Post Master Tribunal Convened under Article nine of the General Post Articles

On the 22^{nd} day of **February** in the year 2015, three General Post Masters in assembly convened to discuss:

- 1. The appointed Office of Governor for The United States of America, held by Gregory Todd Johnstone; and
- 2. General Post Master affirmations for Gregory Todd Johnstone and Phillip M. Renzullo.

WHEREAS, Gregory Todd Johnstone has been accused and he has admitted to sending emails to Phillip M. Renzullo and discussing an American National regarding false claims against that American National; and

WHEREAS, by sending the aforementioned emails, Gregory Todd Johnstone caused Phillip M. Renzullo to fear for his life and safety as well as that of his family; and

WHEREAS, Phillip M. Renzullo has accused Gregory Todd Johnstone of sending him emails that gave him the impression that all American Nationals were going to get arrested for claiming a Nationality, causing Phillip M. Renzullo and his sister Paula Renzullo who is also an affirmed American National; to fear for their life and safety; and

WHEREAS, fearing for their life and safety; Phillip M. Renzullo and Paula Renzullo distanced themselves from their Government of The United States of America, and

WHEREAS, Phillip M. Renzullo has accused Gregory Todd Johnstone of sending him emails which Gregory Todd Johnstone has admitted; which contained an attachment of a letter rescinding all signatures on their Declaration of Exile, Oath or Affirmation for American National, and Oath or Affirmation for General Post Master, and any and all other documents their signatures have been affixed; and

WHEREAS, it is the judgment of these three General Post Masters convened at this time that Gregory Todd Johnstone and Phillip M. Renzullo failed to fulfill the oath or affirmation in the General Post Articles, as amended on the 18th day of February, 2013; Article nine; General Post Master Affirmation, which reads in part:

"...and that I will not at any time do or cause to be done, any matter or thing, that will be prejudicial or injurious to the freedom and Independence thereof; and, also, that I will discover and make known to

someone Citizen while holding the office for The General Post Master for The United States of America of the said State all treasonous or traitorous conspiracies which I now have or hereafter shall know to be formed against this or any of The United States of America.", and

BE IT RESOLVED THAT, after careful deliberation the Tribunal has decided to suspend the affirmations for General Post Master for Gregory Todd Johnstone and Phillip M. Renzullo for a period of five (5) years for Gregory Todd Johnstone committing a crime and Phillip M. Renzullo for failing to report a crime in a timely manner; after which, the aforementioned will have a review by the Post Master General for consideration to lift the suspension, and

FURTHER BE IT RESOLVED THAT, although Phillip M. Renzullo did not report a crime in a timely manner, the Tribunal has taken it into consideration that the crime was eventually reported. Therefore, if the emails that were sent to Phillip M. Renzullo from Gregory Todd Johnstone do materialize, the Tribunal will have no choice but to re-classify a crime not being reported in a timely manner to a crime has been reported which will make Phillip M. Renzullo eligible for re-instatement to resume the duties of a General Post Master, and

FURTHER BE IT RESOLVED THAT, this decision does not affect their American National status nor RESIDENT DECLARATION.

WHEREAS, the actions and violations by Gregory Todd Johnstone have raised the question if he would be able to honor the oath or affirmation for the Office of Governor for The United States of America since he did not honor his oath or affirmation for General Post Master; and

BE IT RESOLVED THAT, after careful deliberation, the Tribunal has decided to recommend that Gregory Todd Johnstone resign from the Office of Governor immediately, otherwise the process for impeachment shall commence by the assembly, and

Under the conditions of Article nine of the General Post Articles, as amended February 18th 2013, Gregory Todd Johnstone and Phillip M. Renzullo do not have any right of appeal of this decision nor do they have a right to speak in their defense or be present during the deliberation over this decision. The Tribunals decision is final.
