WHEREAS, the Human Rights Tribunal International has declared that Human Rights violations do exist in the above-referenced case, on the 300th day in the year of Yahweh, 6018 (Translation: January 12th, 2017); and

WHEREAS, the General Post Master Council has awarded an ASSESSMENT FOR DAMAGES on the 304th day of 6017 (January 19, 2016); and

BE IT RESOLVED, that in regards to **damages by Kate Brown and immediate family** named in the above-referenced case, the Ministry of Finance of the reign of the heavens society Temple hereby declares the assessed value of this case in the total amount of <u>fifty-three million</u>, <u>eight hundred fifty seven</u>, <u>one hundred and forty nine</u> (+53,857,149.00) payable in Legal Tender under the classification of a fine; and

FURTHER BE IT RESOLVED, that in regards to **damages by Claudia Burton and immediate family** named in the above-referenced case, the Ministry of Finance of the reign of the heavens society Temple hereby declares the assessed value of this case in the total amount of <u>two hundred twenty-nine million</u>, <u>eight hundred fifty seven</u>, <u>one hundred and seventy</u> (+229,857,170.00) payable in Legal Tender under the classification of a fine; and

FURTHER BE IT RESOLVED, that in regards to damages by Nancy Doty and immediate family named in the above-referenced case, the Ministry of Finance of the reign of the heavens society Temple hereby declares the assessed value of this case in the total amount of two hundred twenty-nine million, eight hundred fifty seven, one hundred and seventy (+229,857,170.00) payable in Legal Tender under the classification of a fine; and
