MINUTES OF THE MEETING

On the 27th day, in the year of YHWH [Translation: April 15, 2017, at 7:00 UTC-6]. The reign of the heavens Society Board, Society assembly, and all other interested persons convened Temple Service, identified as: 20170415-RHS-MMIN; and

WHEREAS, a motion by the trustees of the temple of YHWH was heard by the Temple assembly, the Subject Matter of the Motion is to Nationalize all the States Constitutions, the motion either grants or restores the metes and bounds back to the original States of the Union constitutions thereby restoring its independence and international character as a subject of the Law of Nations; and

BE IT RESOLVED THAT, the Temple assembly passed the motion and **therefore, the motion hereby** places all 48 States Constitutions back under the original flags of the States of the Union of 1775 to present by Nationalization; and

BE IT RESOLVED THAT, the trustees of the temple of YHWH hereby place this Nationalization Subject Matter into the National assembly for the Government of The United States of America as notification that the trustees are in agreement with the political decision of the North American National Party, and

BE IT RESOLVED THAT, the meeting for the reign of the heavens Society Temple is so adjourned on the 27th day, in the year of YHWH [Translation: March 11, 2017, at 9:00 UTC-6], to re-convene at a future date certain; and

SO ACCEPTED, on the 27th day, in the year of YHWH [Translation: April 15, 2017, at 10:00 UTC -6)]
