



Articles of Association for the Grantors, the people and other county government assemblies and The United States of America, as amended

Article I

Freedoms, Petitions, Assembly, Settlement Board

It is forbidden within The United States of America to attempt to make any regulation respecting an establishment of religion, prohibiting the free exercise thereof; abridging the freedom of speech, or freedom of the press, the right of the Grantors, the people, peaceably to assemble, and to petition the United States, in Congress assembled, for a redress of grievances by and between the Grantors, the people for The United States of America. The United States, in Congress assembled, shall serve as a Settlement Board, among other duties, by and between the county government assemblies for The United States of America. No county government assembly shall have any power of attorney to speak for another county government assembly, as any power of attorney violates the Sovereignty of the county government assembly as parties ratified for The United States of America.



Article II

Right to Peace

A well-regulated Militia, being necessary to the security of a free county government assembly, the right of the Grantors, the people to keep and bear Arms, shall not be infringed nor proposed by any Branch for The United States of America nor any Branch for any county government assembly as parties ratified for The United States of America, nor any county, city, city-state, or any other body politic, association, corporation, and court.

Article III

Quartering of soldiers

No Soldier shall, in time of peace, or in time of war, be quartered in any house, without the consent of the Family.

Article IV

Invasion

The right of the county government assembly to be secure in their territories, offices, duties of their trust representing trade for the county government assembly in The United States of America, against invasion from The United States of America, or any other county government assembly outside or from within shall not be violated. It is Treason by the office holders holding office within The United States of America, or within the county government assembly, to consider and participate in such invasion. The penalty for Treason shall be decided by The General Post Master Council for The United States of America.

Article V
Forbidden, Title of Nobility, Private Central Bank

It is strictly forbidden for any county government assembly to issue or Grant a Title of Nobility as it violates the equalization process in The Universal World Peace Treaty. All Citizens and Nationals for their county government assembly have equal right of suffrage. It is forbidden for any county government assembly within The United States of America, nor the United States, in Congress assembled, to allow or contract out to any privately owned central bank of any sort, anywhere, within The United States of America or outside The United States of America.

Article VI
Right to a fair trial

In all criminal prosecutions, there shall be no criminal prosecutions against any county government assembly by any other county government assembly or by The United States of America. That right shall be retained by the Citizens and Nationals for the county government assembly wherein the Citizen and National shall be a Party to that county government assembly and shall have ratified the Articles of Confederation, as amended.

Article VII
Rights in common law cases

In Suits in common law, where the value in controversy shall exceed twenty in currency, the right of trial by Settlement Board shall be guaranteed to all Citizens and Nationals for their county government assembly, and no fact tried by a Settlement Board within their counties shall be otherwise re-examined in any other county government assembly, or by The General Post Master Council for The United States of America, as appellate for Treaty Violations, than according to the rules of the common law.

Article VIII
Sanctions, fines, consequences

Excessive sanctions shall not be required, nor excessive fines imposed, nor cruel and unusual consequences inflicted upon any county government assembly by any other county government assembly. The Grantors, the people in any capacity within The United States of America shall be guaranteed a blanket "Certificate of Indemnity" from cradle to grave unless found guilty of a crime in a "Trial by Settlement Board" of any injury against another Grantor, the people within The United States of America, in order to uphold the "Innocent until proven Guilty" principal of all Judicial Branches within The United States of America. All cases shall start out in common law and strictly forbidden to start with any criminal prosecution.

Article IX
Immunities in common law by the Citizens and Nationals

The enumeration in the Articles of Confederation, as amended, of all immunities in common law shall not be construed to deny or disparage any immunity in common law retained by all Grantors, the people in their capacity as Citizens and Nationals for their county government assembly within The United States of America.

Article X
county government assembly Rights

The powers not delegated to The United States of America by the Articles of Confederation, as amended, nor prohibited by it to the county government assembly, are reserved to the county government assembly respectively, and all immunities in common law are guaranteed to the Grantors, the people in their capacity as Citizens and Nationals for those county government assembly for The United States of America. All documents shall be written in accordance to the rules of the American English Language in common usage in common law as opposed to civil law to adhere to The Universal World Peace Treaty. All Confederacy right are strictly reserved to the Grantors, the people in their Citizen and National status and private status for The United States of America to ensure a free Market perpetually.
