On the **second day, in the year of Yahweh, six thousand and eighteen, translation 21<sup>st</sup> day of March, two thousand and sixteen**, at 1:00 Universal Time -6, the American Nationals for the Government of The United States of America, and all other interested persons convened a meeting for the assembly, identified as **20160321-SOS-OAR**.

**WHEREAS**, there are court cases within the States that have not been reported to Rosa Gumataotao Rios-Treasury of the United States, and

**WHEREAS**, as a result, court cases have not been registered as assets for the government of the United States by Rosa Gumataotao Rios; and

**WHEREAS**, Rosa Gumataotao Rios is not able to order treasury notes from the mint; and

**WHEREAS**, this report from the office of the Treasury for the Government of The United States of America will allow Rosa Gumataotao Rios to issue a formal protest, that the States are violating their obligation to register cases with her office; and

**WHEREAS**, the office of the Treasury for the Government of The United States of America currently sends payments for monetary damages in Continental Dollars to the International Monetary Fund (IMF); and

**BE IT RESOLVED**, that a motion was carried by the assembly of Affirmed American Nationals to change the process of paying monetary damages in Continental Dollars from the office of the Treasury for The United States of America to the Treasury of the United States, instead of the International Monetary Fund (IMF); and

**FURTHER BE IT RESOLVED**, that this will force the claimants to register their case to collect any monetary damages; and

**BE IT RESOLVED**, that a motion was carried by the assembly of Affirmed American Nationals to request that the United States, in Congress assembled order an additional +100,000 Continental Dollars for continued aid with the DISASTER RELIEF PROJECT FOR THE HOMELESS; and

**FURTHER BE IT RESOLVED**, that the United States, in Congress assembled hereby orders various increments of Continental Dollars totaling one hundred thousand (+100,000) Continental Dollars by the office of the Treasury for the Government of The United States of America; and



**BE IT RESOLVED**, that a motion was carried by the assembly of Affirmed American Nationals to accept “The Continental Army for The United States of America-voluntary militia” seal:



**FURTHER BE IT RESOLVED**, that a motion was carried by the assembly of Affirmed American Nationals to approve the following ranks within The Continental Army for The United States of America-voluntary militia:

**FURTHER BE IT RESOLVED**, that a motion was carried by the assembly of Affirmed American Nationals to adopt the following CODE OF CONDUCT FOR THE CONTINENTAL ARMY;

#### **CODE OF CONDUCT FOR THE CONTINENTAL ARMY**

- 1. I am an American fighting man. I serve in the forces which guard my country and our way of life. I am prepared to give my life in their defense.*
- 2. I will never surrender of my own free will. If in command, I will never surrender my men while they still have the means to resist.*
- 3. If I am captured, I will continue to resist by all means available. I will make every effort to escape and aid others to escape. I will accept neither parole nor special favors from the enemy.*



4. *If I become a prisoner of war, I will keep faith with my fellow prisoners. I will give no information, or take part in any action which might be harmful to my comrades. If I am senior, I will take command. If not, I will obey the lawful orders of those appointed over me and will back them up in every way.*

5. *When questioned, should I become a prisoner of war, I am bound to give only name, rank, service number and date of birth. I will evade answering further questions to the utmost of my ability. I will make no oral or written statements disloyal to my country and its allies or harmful to their cause.*

6. *I will never forget that I am an American fighting man, responsible for my actions, and dedicated to the principles which made my country free. I will trust in my God and in The United States of America.*

**BE IT RESOLVED**, that a motion was carried by the assembly of Affirmed American Nationals to appoint William Ralph Davidson as Trustee for the “reign of the heavens Healing Center”; and

**FURTHER BE IT RESOLVED**, the office of the Coroner is hereby moved under the authority of the reign of the heavens Healing Center; and

**BE IT RESOLVED**, that a motion was carried by the assembly of Affirmed American Nationals to create an obituaries page in the American Herald newspaper; and

**WHEREAS**, the assembly of Affirmed American Nationals have addressed all issues and resolutions on the agenda file name 20160321-Agenda for Assembly;

**BE IT RESOLVED**, the meeting for the assembly adjourned on the **second day, in the year of Yahweh, six thousand and eighteen, translation 21<sup>st</sup> day of March, two thousand and sixteen, at 4:00 Universal Time -6** to re-convene at a future date certain.
