**BE IT RESOLVED**, a motion for the following: The United States, in Congress assembled hereby proclaims an international objection on the public record to the existence of the Declaration of North America (hereinafter "declaration") published on (January 10th, 2023) by the Biden Administration Briefing Room in collaboration with Andrés Manuel López Obrador and Justin Trudeau. This declaration would potentially create a political subdivision superstate to claim power of attorney over millions of inhabitants, and is evidence in and of itself of the existence of Human Rights violations, including but not limited to trafficking in persons of thousands, throughout the borders of the metes and bounds and seaward boundaries of The United States of America; and

**BE IT RESOLVED**, a motion to amend the Enactment clause verbiage discussed at the General Post Masters meeting Wednesday Jan 18, 2023 to:

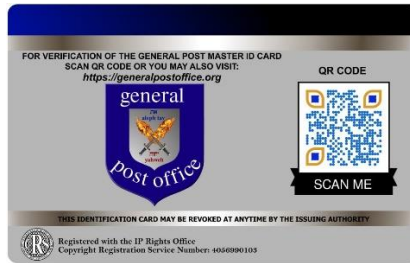
Enactment clause: “Under the authority and command of יהושה, it is hereby petitioned that all deceptions are legislated out of existence by the National assembly of American Nationals, in social compact, and all Acts petitioned, accepted, and acknowledged by the current United States, in Congress assembled in the same light.

The petition is hereby ordained in His name יהוה through His Son in the light of the Set-apart Spirit to accept His condemnation to end the deception of who we are, our rebellion, and our rejection so the suffering of eternal ruin among the people is eliminated to clear the path of the narrow way to salvation.

To perpetuate the salvation process of exposing the evil or deception within; the petition is hereby brought before the Public that cannot be settled internally, and to warn others of the delusions of the heart as we repent of our delusions and deceptions towards others, the National assembly of American Nationals hereby enact the following under the authority and in the name of יהושה; and



**BE IT RESOLVED**, a motion for the National assembly to Accept and Acknowledge front and back templates for the issuance by the General Post Office, used for Identification of a Letter Carrier for the Government of The United States of America;



and

**BE IT RESOLVED**, the meeting for the National assembly adjourned on the 310<sup>th</sup> day, in the year of Yahweh, six thousand and twenty four, translation 23<sup>rd</sup> day of January, two thousand and twenty three at approximately 9:18 Universal Time -6 to re-convene at a future date certain.

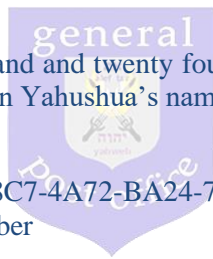
